August 14, 2017 **MINUTES**

I. The Board of Trustees for the East Glacier Park Grade School, School District No. 50, held their Special Budget Board meeting on Monday, August 14, 2017 in the school lunchroom. Brian Gallup, chairperson, called the meeting to order at 6:07 p.m. Members present: Brian Gallup, Missy Gordon, and Joni Woldstad.

Trustee Harley DeCarlo was absent.

Others present: Karlona Sheppard and Denise Mason.

Visitors: Randy Sheppard and Marion Woldstad.

- II. Visitors were recognized.
- III. The procedure for addressing the Board was explained.
- IV. A motion was made by Joni Woldstad and seconded by Brian Gallup to approve the agenda. The motion passed unanimously.
- V. A motion was made by Joni Woldstad and seconded by Brian Gallup to approve the July 24 Minutes. The motion passed unanimously.
- VI. Vacant Trustee Position Appointment:
 - A. Joni Woldstad motioned to accept by appointment (1) trustee, Randy Sheppard, to serve out the remaining 9 months until the May 2018 School Election in accordance with 20-3-308 and 20-3-309 MCA. The Trustee position will be up for election in the May 2018 School Election for the remainder of its term (one year, ending May 2019). Brian Gallup seconded the motion. The motion passed unanimously.
 - B. District Clerk Denise Mason gave the Oath to Newly Appointed Trustee, Randy Sheppard, for a nine (9) month term.

- VII. Final Budget for 2017-2018: A motion was made by Brian Gallup and seconded by Joni Woldstad to open the budget meeting for fiscal 2017-18. The motion passed unanimously.

Brian Gallup reported that he had met with Glacier County Superintendent of Schools Darryl Omsberg. Darryl Omsburg has advised that the East Glacier Park School Board not approve a budget for 2017-18 without balancing first with the County Treasurer's office and signing off on the County's final fund balances. The County Treasurer's office has not provided final June Cash Reports, as required. No Glacier County school was in balance with the County Treasurer as of August 14, 2017. Denise Mason reported that the County was still working with their auditor to sort out final cash balances for schools and that to date, she could not produce a final 2016-17 Trustees Financial Summary or 2017-18 Budget. All remaining budget items: Tabled.

- VIII. Principal's Report: Kar Sheppard reported that the trailer classroom had not arrived on time and she would be following up the rest of the week to get an accurate delivery date. Brian Gallup added that the plan would be to install a level walkway from the school to the new building and provide a handicap exit to the outside.

XII. New Business:

- A. Joni Woldstad motioned to approve the Investment Agreement with Glacier County for 2017-2018. Brian Gallup seconded the motion. Mrs. Woldstad asked Ms. Mason why she was submitting an investment agreement from the school rather than signing the agreement from Glacier County. Ms. Mason reported that the County had not produced an Investment Agreement for 2016-17 nor 2017-18 and she thought it best to have something in place with the County to protect the school's investments. The motion passed unanimously.
- B. Joni Woldstad motioned to approve the Schedule of Salaries for submission to the County Superintendent. Brian Gallup seconded the motion. The motion passed unanimously.
- C. Joni Woldstad motioned to hire half-time teacher L. Racine as a full-time teacher. Randy Sheppard seconded the motion. The motion passed unanimously. Chair Brian Gallup signed the updated 2017-18 contract.
- D. Kar Sheppard reported that two people were interested in the half-time teacher position, but did not complete the application process to go through with interviews. Mrs. Sheppard will continue to follow-up with interested applicants.
- E. Denise Mason briefed new Trustees on Senate Bill 307 Building Reserve Fund Permissive Levy. Until she is balanced with the County Treasurer, Ms. Mason reported that she will be unable to provide details on how this bill will impact taxes in the Building Reserve fund, but hoped to shift the SB307 permissive levy mils to replace some of the voted levy mils in the Building Reserve, in order to leverage matching funds from the State, but keep total taxes the same. Considerations for the Board to discuss in the future include whether or not to keep taxes the same in the

- Building Reserve Fund, and the State requirement to spend the permissive levy on any projects remaining from the 2008 Facility Condition Inventory and Energy Study for the East Glacier Park Grade School. Joni Woldstad thought that replacing the single pane windows remaining in the building, particularly in the lunchroom, would reduce energy costs for the school.
- F. Denise Mason reported that it is possible to bill Medicare for some school-based services such as speech-language services for children with an IEP (Individualized Education Plan) who are eligible for Medicare. There are private companies who provide billing support. Ms. Mason will follow-up with the State Medicaid representative and other Montana schools to find out more information on how this reimbursement works. The Board supported Ms. Mason to gather more information.

Impact Aid received approximately 96% of expected

payments last year. Mr. Gallup advised the Board to be very cautious with spending as we move forward.
