The Board of Trustees for School District #50, East Glacier Park, Glacier County, State of Montana, will hold the Annual Regular School Election on: Tuesday, May 5, 2020 which date is not less than seventy (70) days after the passage

of this resolution.

THE ELECTION: will be conducted by Poll Election.

## **PURPOSE OF THE ELECTION:**

To elect two (2) trustees for a three (3) year term, or as otherwise designated.

To impose an additional levy to operate and maintain the General Fund for 2020-2021. To impose an additional levy for the Building Reserve Fund of this school district for the purpose of building, building repairs, equipping of the school buildings, and operation and maintenance of the school building. The Board has determined the local taxes to support the Building Reserve Fund in the amount of \$45,000.00 which is approximately 20.26 mills.

To allow the transfer of funds and budget authority from the transportation fund to the flex fund as the trustees determine needed to a maximum of \$50,000.00 to improve the efficiency of spending in the 2020-2021 school year to be used for the general operation, maintenance, utilities, wages, benefits, equipping, and supplying of school district #50. This transfer if approved by the voters is in compliance with MCA 20-9-208.

If any of these judges should not be able to serve, Denise Mason, the election administrator, will choose a replacement from certified judges.

As has also been the practice of the District, and in accordance with Montana law, if any Board or public representative desires to speak to an item that is *specifically listed/identified on the agenda*, you will be allowed to do so at the discretion of the Board chairperson when the item comes up for discussion and action. The public comment portion of the agenda is not the time designated to hear items that are specifically listed/identified on the agenda.

For those individuals who desire to address the Board during the "public comment" portion of the meeting, if you haven't already done so, please sign your name to the sheet located on the table and indicate the general topic on which you will be commenting. The Board Chairman will call individuals to speak in the order listed on the sheet provided. The Board would like to remind everyone in attendance that to avoid violations of individual rights of privacy, a member of the public wishing to address the Board during this time will not be allowed to make comments about any student, staff member, or member of the general public during his/her designated time to speak. In addition the Board will not hear comments on contested cases or other adjudicative proceedings.

Depending on the number of persons who wish to address the Board, the Board Chairman may place reasonable time limits on comments, in order to maintain and ensure effective and efficient operations of the Board.

By law the District cannot take any action on any matter discussed during the "public comment" portion of the meeting, until such time as the matter is specifically noticed on the agenda, and the public has been allowed the opportunity to comment.

Board meetings are open to the public, but not a public meeting.
