

East Glacier Park Grade School Safe Return to School Plan

Full Opening for Face-to-Face Instruction for 2021-2022 School Year

Learning Model

- Continue Social Distancing.
 - 3 feet apart as recommended by CDC.
- Full day instruction with all students in the building.
- Weekly Staff meetings on Mondays after school.

Safety/Cleaning for COVID-19 Prevention and Management

- All staff and student symptoms are monitored at the building entrance by hall monitor to ensure safety of all students and staff. Temperatures are taken, and sign-in is required for contact tracing.
- Use of face masks required inside the building following CDC guidelines.
- Masks required at recess if kids are closer than 3 feet outside.
- Masks are provided by the school if necessary.
- Regular daily cleaning taking place.
- Extra wipe-downs of all common surfaces- door knobs, railings, bathrooms, sinks, coffee area, etc.
- Fridays off used for deep cleaning.
- Hall monitor wipes down the bathroom after each use.
- Hall monitor wipes down heavy traffic areas throughout the day.
- Only scheduled guests will be allowed in the building.
- If a child is sick with any symptoms, parents are contacted. Students are covid tested after obtaining parent permission. Students are then sent home if symptoms are likely to spread sickness.
- If a staff member is sick, they are covid tested and stay home if they have symptoms that are likely to spread sickness.
- Confirmed covid case closes building for minimum 1 day for deep cleaning-contact tracing.
- Confirmed case in a classroom moves that room to remote learning for a minimum of 1 day.
- Confirmed cases follow CDC school closure recommendations.

- If someone tests positive they stay home for 10 days from first symptoms, or what public health officials require.
- If a student tests positive they are provided work for home.
- If students have a close contact in their home they stay home for

recommended time according to health officials.

- Teachers have emergency packets for remote days due to COVID.
- Teachers have computers checked out for days the school building is closed.
- Lunch in the gym for many classrooms- children choose lunch and carry the tray to the gym. Petersen and Sibbersen classes eat in lunchroom.
- Breakfast in the gym..
- If a staff member tests positive they must stay out of the building until they are off quarantine.
- Teachers use Google Classroom to familiarize students, and have a remote learning daily schedule prepared.
- Staff training on SafeSchools.com.
- Designated bathrooms for different grades.
- Increased family outreach through Remind app, Facebook, and Google Surveys.
- The After School Program limits space due to the size of room available.
