

## EHEMS Parental Involvement Policy

### PART I. GENERAL EXPECTATIONS

The East Hardy Early Middle School agrees to implement the following statutory requirements:

The **East Hardy Early Middle School** shall take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002):

8. The **East Hardy Early Middle School** shall provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described below --

- how to monitor their child's progress, and

9. The **East Hardy Early Middle School** shall provide materials and training to help parents work with their children in the areas of improving student achievement, (including literacy training and using technology) child development, child rearing and additional topics parents may request.

10. 
