School Responsibilities

The Dixon Elementary School will:

- 1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows:**
 - Maintain 100% highly qualified faculty.
 - Actively engage students in the learning process.
 - Provide specialized services needed to improve student performance.
 - Encourage and guide students to use a variety of thinking and reasoning strategies and routinely monitor and report progress toward achieving learning goals.
 - Enable students to achieve by having high expectations for attendance and student learning.
 - Utilize a variety of assessments that gives all students an opportunity to demonstrate achievement and implement diverse instructional approaches to accommodate differences in student learning.
 - Engage in practices that support the ongoing improvement of teaching and student performance.
- 2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.** Specifically, those conferences will be held:
 - Parents are required to attend a minimum of two parent-student-teacher conferences per year.
 - At least one conference will be scheduled to take place during first quarter, and another during third or fourth quarter.
- 3. Provide parents with frequent reports on their children's progress.** Specifically, the school will provide reports as follows:
 - Report cards are sent home after each quarterly grading period.
 - Progress reports will be sent home monthly and at mid-quarter each quarter.
 - Parents may also log on to STI Home (mcpss.com) to check grades. Notification of access codes will be distributed at the beginning of the school year.
- 4. Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as follows:
 - Teachers may be contacted by sending a note to the teacher or by calling the school office at 824-4314. During class time, phone messages are taken in the office and placed in the teacher's mailbox.
 - Teachers can meet with parents for a conference before school, after school, or during their planning period, depending on their schedule.
- 5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:**
 - Inform parents of upcoming activities, events, and programs on the website (<http://dixon.mce.schoolinsites.com>) and in parent bulletins that will be sent home at least monthly to assist in planning opportunities for involvement.
 - Utilize leadership notebooks to effectively communicate with parents on a daily basis with regards to class and/or student activities where parents may volunteer, participate, and observe in the classroom.

Parent Responsibilities

- Ensure my child's punctuality, school attendance, and compliance with attendance rules and procedures.
- Support discipline policies of the classroom and school.
- Support my child's preparation for and completion of upcoming assignments and tests by maintaining a time and place for homework, reviewing schoolwork regularly, and providing necessary supplies and supervision.

- Stay informed about my child's education by attending scheduled conferences and meetings.
- Communicate with the school by promptly reading all notices from the school or the school district either received by my child or by mail and respond, as appropriate.
- Serve, to the extent possible, on advisory groups, such as Title I advisory committees and parental involvement committees.
