School Responsibilities

The Dixon Elementary School will:

 - Utilize a variety of assessments that gives all students an opportunity to demonstrate achievement and implement diverse instructional approaches to accommodate differences in student learning.
 - Engage in practices that support the ongoing improvement of teaching and student performance.
- Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.** Specifically, those conferences will be held:
 - Parents are required to attend a minimum of two parent-student-teacher conferences per year.
 - At least one conference will be scheduled to take place during first semester, and another during second semester.
- Provide parents with frequent reports on their children's progress.** Specifically, the school will provide reports as follows:
 - Report cards are sent home after each quarterly grading period.
 - Progress reports will be sent home monthly and at mid-quarter each quarter.
 - Parents may also log-in to INOW(mcpss.com) to check student grades. Notification of access codes will be distributed at the beginning of the school year.
- Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as follows:
 - Teachers may be contacted by sending a note to the teacher, email, class messaging, or by calling the school office at 251-824-4314. During class time, messages taken in the office are delivered to the teacher's mailbox.
 - Teachers can meet with parents for a conference before school, after school, or during their planning period, depending on their schedule.
- Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:**
 - Inform parents of upcoming activities, events, and programs on the website (<http://dixon.mce.schoolinsites.com>), through social media, and in parent bulletins that will be sent home at least monthly to assist in planning opportunities for involvement.
 - Utilize student leadership notebooks to effectively communicate with parents regarding class and/or student activities where parents may volunteer, participate, and observe in the classroom.
- Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand, as follows:**
 - Information on all school programs, activities, events, parent meetings, school and classroom newsletters, parent notices, etc. is sent to parents in other languages as requested.
 - Utilize ESL Federal Programs services/support to provide interpretation assistance in verbal/written communications with parents as requested/needed.

Parent Responsibilities
