

**DADE ELEMENTARY SCHOOL
PARENT INVOLVEMENT POLICY**

GENERAL EXPECTATIONS

Dade Elementary School agrees to implement the following policies:

- o Dade Elementary School will jointly develop with parents and distribute to parents of participating children, a Parental Involvement Policy that the school and parents of participating children agree on.
- o Dade Elementary School will notify parents about the Parental Involvement Policy in an understandable and uniform format and, to the best of their ability, will distribute this policy to parents in a language the parents can understand.

Dade Elementary School will implement required school parental involvement policy components as follows:

1. Dade Elementary School will take the following actions to involve parents in the joint development and joint agreement of its Parental Involvement Policy and its school wide plan, if applicable, in an organized, ongoing, and timely way under section 1118(b) of the ESEA.

 - o *Parents will be notified about meetings through school memos, newsletters, and school web page.*

Dade Elementary School will provide information about Title I programs to parents in a timely manner through the memos, newsletters, and the web page.

Dade Elementary School will provide parents of participating children with a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet through:

- Annual Title I parent meeting
 - Parentteacher conferences
 - Title I meetings and PTO meetings throughout the year
- (a) If requested by parents, Dade Elementary School will provide parents opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicable possible:
- Through prearranged meetings with the Title I Coordinator
 - Through meetings with the student's teacher which may include the Title I Coordinator, the principal, and other staff as appropriate
 - Dade Elementary School will submit to the district any parent comments if the school wide plan under section (1114)(b)(2) is not satisfactory to parents
 - Parents may submit comments in writing regarding the school wide plan to their child's teacher, the Title I Coordinator, the principal, or the appropriate department within Dade County School District

RESPONSIBILITIES FOR HIGH STUDENT ACADEMIC ACHIEVEMENT

1. Dade Elementary School will build the schools' and parents' capacity for strong parental involvement in order to ensure effective involvement of parents and to support a partnership between the school, parents, and the community to improve student academic achievement through the following activities described below:

- Parent training
- Grade level parent transition meetings
- Family nights
- Parental access to the Parent Resource Room and other resources such as web sites, parent organizations, etc.
