### Eagle River Christian School Before and Aftercare Program KR-6<sup>th</sup> Grade

Due to safety of children, school liability, and parent responsibility, the following procedures will be enforced. Any child who arrives at school before 8:00 A.M. or who remains after 2:40 P.M. and is not directly supervised by a parent or their official designee will be placed in Before/After Care and charged for services. This includes parking lots and grounds. Persons who are responsible and are in direct supervision of the children should accomplish pick-up and deliveries. With increased enrollment there are increased traffic and safety issues.

Before/After Care is available from 7:00 A.M. to 6:00 P.M., Monday through Friday when school is in session. This is a school extension and is not available to other children. After 6:00 P.M. parents will be charged \$1 per minute.

Students must be signed in and out (by an adult only) of the Child Care program to indicate time and the person taking charge of the student(s). A person other than the parent, whom picks up a student(s) must show I.D. and be on the emergency list and the parent must have contacted the school office.

Children should bring their own snacks for before and after care (microwave items allowed). NO breakfast will be made after 7:30 am.

Please check the appropriate possible use of before and after school care. There is no obligation to complete this except to help us to plan for appropriate supervision. In order to keep charges reasonable, charges cannot be prorated hourly. You will be billed at the end of the month. There is a discount for each additional students.
