

ATTENDANCE 2016-2017





GRADUATION RATE 2015-2016






CHILTON COUNTY DROPOUT RATE


5 YEAR COMPARISON


Chilton County Five-Year Dropout Trend

WHAT IS HOMELESS?



According to the McKinney-Vento Homeless Education Assistance Improvement Act of 2001, students are considered homeless if they lack a fixed, regular, and adequate nighttime residence.

Examples of Homeless include the following:

- Sharing a house with someone due to loss of house or economic hardship
- Living in Hotels/Motels/Shelters
- Living in a Camp Ground
- Living in an Automobile, Parks, Abandoned Buildings
- Living in a public or private place not designed for sleeping accomodations
- · Unaccompanied Youth, not in the company of a parent or guardian

HOMELESS...

- 36 Students Identified
- 26-More than one family in house
- 6-Living with friends or family
- ❖ 4-Hotel/Motel

2015-2016

- 24 Students Identified
- 4-More than one family in house
- 5-Living with friends or family
- ❖ 5-Hotel/Motel
- All identified homeless students receive free meals
- Additional services are provided upon request of school counselor, social worker, and/or parent quardian
- Outside community resources are referred as needed for housing, power bill, food, etc.
- Homeless Set Aside = \$500 (Allowable Expenditures: school clothes, medical/dental/vision, tutoring, transportation, school fees, field trips, personal items-soap, shampoo, etc

EL Info...

- Since 2010, over 1,200 students have been in the EL program. This includes students who have withdrawn and are no longer in our school system.
- It takes 3+ years for students to gain English skills.
- ❖ It is rare for K-2nd grade and LEP 1 Middle School/High School students to exit ESL program in less than 1-2 years.
- Their scores still count toward achieving the target goal in AMAO-B.
- Chilton County currently serves the following students: Mexico, Guatemala, Honduras, El Salvador, Argentina, India, China, Korea, Vietnam, Ukraine, Brazil, and Philippines.
- ❖ LEP 1 First year in United States
- ❖ LEP 2 Currently receiving EL services
- ❖ FLEP 1 Students met goal and entered 1st year monitoring
- ❖ FLEP 2 Students met goal and are in 2nd year of monitoring
- FLEP Students who exited program
- ❖ NOMPHLOTE Student did not qualify for EL services based on screener



WHAT ARE AMAOS?

> AMAO status is based on ACCESS for ELLs results

- AMAO-A Each student taking the ACCESS for ELLs must make progress by .5 CPL. Overall 53% of ELs must make this gain. This % increases each year. By 2019, 61% must how improvement.
- AMAO-B 19% of ELs must achieve 4.8 or higher on the ACCESS for ELLs. By 2019, 25% must achieve the State's benchmark. There is a possibility that the benchmark will change to a higher score.

2016-2017 DISTRICT-WIDE GOALS

- · Goal 1-All EL students will become proficient in attaining language proficiency or AMAO-B.
- ✓ El teacher will provide language arts standards during a protected instructional time at least 30 minutes per week.
- ✓ Professional development will be conducted by the EL teachers to provide academic teachers and special education teachers with training needed to connect the WIDA standards with the language arts standards.

- Goal 2-Chilton County will increase the percentage of high school students earning college credits in English Language Arts, Social Studies, and other approved electives
- ✓ A 1% increase of Eleventh and Twelfth grade students will demonstrate a proficiency Social studies and other approved electives by increasing the number of students from 17% to 18% in English Language Arts by 05/25/2017 as measured by the number of college credits earned by high school students
- ✓ Three school bus routes will be provided to transport students to Jefferson State Community College.

 Students may choose to ride the bus or drive his/her car.

- ✓ A 5% increase of Third, Fourth, Fifth, Sixth, Seventh, Eighth and Tenth grade students will demonstrate a proficiency in the College and Career Reading Standards in Mathematics by 05/25/2017 as measured by ACT Aspire.
- ✓ A 4% increase of Students with Disabilities students will demonstrate a proficiency College and Career Ready Standards in Mathematics by 05/25/2017 as measured by ACT Aspire.

Goal 6-Increase Proficiency in Reading

- ✓ A 5% increase of Fourth, Fifth, Sixth, Seventh, Eighth and Tenth grade students will demonstrate a proficiency in College and Career Ready Standards in Reading by 05/25/2017 as measured by ACT Aspire.
- ✓ A 4% increase of Students with Disabilities students will demonstrate a proficiency in College and Career Readiness in Reading by 05/25/2017 as measured by ACT Aspire.

Goal 7-Increase the percentage of college and career ready students

✓ A 1% increase of Eleventh and Twelfth grade students will demonstrate a proficiency by achieving college and career readiness in one of the following benchmarks in one area of the ACT WorkKeys, one area in the ACT Plus Writing or enlisting in the military in Practical Living by 05/25/2017 as measured by the college career readiness data.




