### **DISCLOSURE OF PROTECTED HEALTH INFORMATION AND CONSENT FOR TREATMENT**

I, the parental/legal guardian, understand that once information is disclosed per authorization or consent, the information is subject to re-disclosure and may no longer be protected by HIPAA and/or the Buckley Amendment. I, the parent/legal guardian, understand that I may revoke this authorization/consent at any time by notifying in writing to the school's athletic director, but if I do, it will not have any effect on the actions the school officials took in reliance on this authorization/consent prior to receiving the revocation. I further have been given a copy of the Privacy Notice, which explains my rights under HIPAA. This authorization/consent expires one year from the date it is signed.
