## **School Responsibilities**

#### We will:

1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State's student academic achievement standards as follows:

In addition to the regular academic course work and the Alabama College and Career Ready Standards, Johnson Elementary School will provide students with opportunities for academic remediation, intervention and enrichment activities in the areas of reading, math, and writing. Technology devices including Promethean/Smart Boards, Mac Books, and iPads are available for all students PreK – 5<sup>th</sup>. Performance Series, Moby Max, and Odyssey instructional software have been implemented in classrooms to provide teachers and students with 21<sup>st</sup> Century technology learning experiences in all subject areas. Contracted services for additional instruction will also be provided.

2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement.

Parent-Teacher conferences will be held whenever requested. Parents will have an opportunity to schedule a conference during the teacher's planning period or after school.

3. Provide parents with frequent reports on their children's progress.

We will provide each parent with a Student Progress Report in the middle of each nine week grading period. We will also provide a Report Card for each student at the end of each nine week grading period. The Progress Report dates for the 2016 - 2017 school year are as follows: September 8, 2016, November 17, 2016, February 19, 2017, and April 24, 2017. The Report Card dates are as follows: October 19, 2016, January 10, 2017, March 24, 2017, and June 1, 2017.

## 4 Provide parents reasonable access to staff.

The staff will be available to meet with parents after regular school hours. Teachers will also be available to meet with parents during their planning periods. Administrators will be available to meet with parents at various times throughout the school day. Parents must call the school to schedule a time to meet with members of the faculty and staff.
