School Responsibility

- 2. Provide parent-teacher-student conferences during which this compact will be discussed as it relates to the individual child's achievement. *These conferences will be held as follows:***
 - Before the end of second quarter to discuss Spring 2016 test results [ASPIRE] and first quarter progress with parents/guardians
 - At any other time that the teacher or parent feels a conference is necessary
- 3. Provide parents with frequent reports on their child's progress. *The school will provide reports as follows:***
 - Progress reports will be sent home mid-quarter
 - Report cards will be sent home at the end of the quarter
 - Grades, attendance, and discipline reports may be accessed through I-Now at any time
- 4. Provide parents with reasonable access to staff. *Access to staff may be made by appointment as follows:***
 - Before and after school
 - During planning period
- 5. Provide parents opportunities to volunteer and participate in their child's class and to observe classroom activities. *Parents are encouraged to:***
 - Volunteer in their child's classroom
 - Participate in Statewide Parenting Day
 - Assist with special events by serving on special committees, field trips, etc.

Parent Responsibility

We, as parents, will support our children's learning in the following ways:

- Support the discipline policies and school-wide rules of the teachers and administrators
- Monitor our child/children's attendance
- Assist with homework and ensure that it is completed and returned
- Stay involved with our child/children's school by:
 - reading and responding to bulletins sent home with our child/children or US Postal Service
 - listening to and responding to the electronic School Messenger messages
 - volunteering in classrooms
 - keeping the line of communication open in order to discuss each day's school activities
- Provide our child/children with appropriate school supplies
- Help our child/children adhere to the uniform policy
- Monitor the amount and content of television our child/children is watching
- Participate in decisions relating to my child/children's education
- Promote positive use of my child/children's extracurricular time
