- Restriction of device usage or activity (teacher discretion)
- Parent/teacher/student conference
- Office discipline referral, administrative action
- Serious violations will be subject to the MCPSS discipline policy

What if my child's device is stolen or damaged?

Students will bring personal devices at their own risk, just like any other personal items. The school will not be held responsible if an electronic device or other item is lost, stolen, or misplaced.

What is BYOD?

BYOD means Bring Your Own Device! With BYOD, students will be allowed to bring their own approved device to use in the classroom as an educational tool.

The BYOD initiative is Optional. Students are NOT required to have personal devices. All students will have equal opportunities to participate in technology activities.

Device Management Guidelines and Student Responsibilities

1. It is the responsibility of the student to maintain the proper care of their device. Any damage that occurs to the device will not be the responsibility of the school or school system.
2. Students will bring approved devices at their own risk, just like any other personal item. The school will not be responsible if an electronic device or other item is lost, stolen, or misplaced. Some devices have a locator, such as Find My iPhone/iPad; it is recommended that you enable this feature if possible.
3. Devices must be charged at home before coming to school daily. Teachers/staff are not responsible for charging devices.
4. Students must already be familiar with their device before bringing it to school, including powering the device on and off, setting it on silent mode, accessing wi-fi settings, and accessing the internet browser. Teachers/staff will not be responsible for training students to use a personal device.
5. All devices must be clearly labeled with the student's name. It is recommended that devices have some sort of protective covering to avoid damage if dropped. (i.e. laptop case, Otterbox, etc.)
6. Devices must remain powered off in the classroom unless otherwise directed by the teacher during acceptable use time.
7. The Mobile County Public School System is not responsible for the purchase of paid applications for personal devices.
8. Students will not be allowed to share personal devices.
9. Posting or transmitting recorded images or video shall be limited to that which is related to school assignments and projects and shall only be done in accordance with the MCPSS Internet Acceptable Use Policy.
10. Misuse of personal devices may result in loss of device privileges.
