MEDICATIONS MUST BE IN THE ORIGINAL CONTAINER AND THE LABEL MUST INCLUDE THE CHILD'S NAME, NAME OF THE MEDICATION, DOSAGE, METHOD OF ADMINISTRATION, AND THE NAME OF THE PHYSICIAN OR LICENSED HEALTH CARE PROVIDER. A PARENT OR AN ADULT MUST DELIVER MEDICATION TO THE SCHOOL.

NOTICE OF PROVISION

Legal References Governing the Administration of Medication in Schools In accordance with the California Education Code Sections 49423, 49423.5, 49480 And California Administrative Code, Title 5, 18170

California Education Code, Section 49423 Administration of prescribed medication for pupil

Notwithstanding the provisions of Section 49422, any pupil who is required to take, during the regular school day, medication prescribed for him by a physician, may be assisted by the school nurse or other designated personnel if the school district receives:

- 1.) A written statement from the parent or guardian of the pupil indicating the desire that the school district assist the pupil in matters set forth in the physician's statement.
- 2.) A written statement from the parent or guardian of the pupil indicating the desire that the school district assist the pupil in matters set forth in the physician statement.

California Education Code, Section 49423.5 Specialized physical health care services

- a. Notwithstanding the provisions of Section 49422, any individual with exceptional needs who requires specialized physical services, during the regular school day, may be assisted by the following individuals:
 - 1.) Qualified persons who possess an appropriate credential issued pursuant to Section 44267, or hold a valid certificate of public health nursing issued by the State Department of Health Services or
 - 2.) Qualified designated school personnel trained in the administration of specialized physical health care provided they perform such services under the supervision of the school nurse, public nurse or licensed physician and surgeon.
- b. Specialized health care or other services that require medically related training shall be provided pursuant to the procedures prescribed by Section 49423.
- c. Persons providing specialized physical health care services shall also demonstrate competence in basic cardiopulmonary resuscitation and shall be knowledgeable of the emergency medical resources available in the community in which the services are performed.
- d. "Specialized physical health care services" as used in the section include catheterization, gavage feeding, suctioning, or other services that require medically related training.
- e. Regulations necessary to implement the provisions of this section shall be developed jointly by the State Department of Health Services, and adopted by the State Board of Education.

California Education Code, Section 49480 Continuing medication regimen for non-episodic condition; required notice to school employees

The parent or legal guardian of any public school pupil on a continuing medication regimen for a non-episodic condition shall inform the school nurse or other designated certificated school employee or the medication being taken, the current dosage, and the name of the supervising physician. With the consent of the parent or legal guardian of the pupil, the school nurse may communicate with the physician and may counsel with the school personnel regarding the possible effect of the drug on the child's physical, intellectual, and social behavior, as well as possible behavioral signs and symptoms of adverse side effects, omission, or overdose. The superintendent of each school district shall be responsible for informing parents of all pupils of the requirements of this section.

California Administrative Code Title 5, 18170 The agency shall follow these provisions pertaining to medication

1. An assigned staff member shall administer medications prescribed by a physician for a child provided written parental consent has been given.
2. Record medication dosages to the child and date and time medication is administered shall be maintained by the facility.
3. Centrally stored medication shall be kept in a safe and locked place that is not accessible to persons other than employees responsible for health supervision. Each container shall carry the name of the medication, the name of the person for whom prescribed, the name of the prescribing physician and the physician's instruction. All centrally stored medication shall be labeled and maintained in compliance with State and Federal laws. Each person's medication shall be stored in its originally received container. **NO MEDICATIONS SHALL BE TRANSFERRED BETWEEN CONTAINERS.** The agency shall be responsible for assuring that a record of centrally stored prescription medications for each person in care includes: the name of the person for whom prescribed the drug name, strength and quantity, the date filled, the prescription number and the name of issuing pharmacy.
4. All medication shall be centrally stored in an area which is totally inaccessible to children.

Código Educativo de California, Sección 49423

Administración de Medicamentos Recetados para los Estudiantes

A pesar de las estipulaciones de la Sección 19122, cualquier estudiante que necesite tomar medicamentos recetados durante el horario escolar, recetados por un doctor para el estudiante, puede ser ayudado por la enfermera de la escuela o por el personal designado, siempre y cuando el distrito reciba:

- 1.) Una nota escrita por el doctor que ha indicado el método, la cantidad, y las horas a las que el medicamento deba ser tomado.
- 2.) Y una nota escrita por los padres o tutores del estudiante, indicando el deseo de que el distrito escolar ayude a su hijo en los asuntos médicos, indicado del mismo modo por el doctor.

Código Educativo de California, Sección 49423.5

Los servicios especializados para el cuidado de la salud física

- a. A pesar de las estipulaciones de la Sección 49422, cualquier individuo con necesidades excepcionales, que necesite servicios físicos especializados durante un horario escolar regular, puede recibir ayuda de los siguientes individuos:
 - 1.) Personas calificadas que posean las acreditaciones apropiadas, extendidas conforme a la Sección 44267, o que tengan un certificado válido de enfermería en salubridad pública, extendida por el Departamento de servicios de Salubridad del Estado.
 - 2.) O por personal calificado y designando de la escuela, que esté capacitado en el cuidado físico, especializado de la salud, siempre y cuando ejerzan tales servicios bajo la supervisión de la enfermera de la escuela, una enfermera pública, o por un doctor acreditado o un cirujano.
- b. Los servicios de salud especializados u otros servicios que requieran de mediana capacitación, deberían ser provistos conforme a los procedimientos indicados en la Sección 49423.
- c. Las personas que ofrezcan servicios especializados y físicos para la salud, deberían además demostrar la capacidad de realizar resucitación cardiopulmonar y deberían de estar al tanto de los recursos médicos de emergencia disponibles en la comunidad, en la cual estos servicios se lleven a cabo.
- d. "Los servicios especializados y físicos para la salud" como se emplea en la sección, incluyen sondas, alimentación por tubos, succión de líquidos, u otros servicios que requieran de cierta capacitación médica.
- e. Las regulaciones necesarias para poner en práctica las estipulaciones de esta sección, deberían de ser desarrollados conjuntamente por el Departamento de Servicios de Salubridad del Estado.

Código Educativo de California, Sección 49480

El régimen de medicamento continuo por condiciones no episódicas; es requerido un aviso para los empleados de la escuela

El padre o tutor de cualquier estudiante en una escuela pública, con un régimen de medicamento continuo por condiciones no episódicas, debe informarle a la enfermera de la escuela, u otro empleado certificado de la escuela, de los medicamentos que el estudiante este tomando, la dosis actual, y el nombre del doctor que lo supervisa. Con el consentimiento del padre o tutor, la enfermera de la escuela puede comunicarse con el doctor para así aconsejar al personal de la escuela de cualquier posible efecto que el medicamento pueda surtir en los secundarios adversos, de la omisión de dosis, o de sobredosis. El superintendente de cada distrito debe ser responsable de informarles a los padres de todos los estudiantes acerca de los requisitos de esta sección.

Título 5, 18170, del Código Administrativo de California

La agencia debe seguir estas estipulaciones referentes a los medicamentos

1. Un miembro asignado del personal debe administrar los medicamentos recetados por un doctor para un niño, siempre y cuando tenga el consentimiento de los padres por escrito.
2. La escuela debe de tener un registro de la dosis del medicamento que debe tomar el niño, así como la fecha y la hora del medicamento que está siendo administrado.
3. La medicina debe guardarse en un lugar seguro y con llave, un lugar central de almacenamiento; a este lugar no deben de tener acceso otras personas que no sean los empleados responsables de supervisar la salud del niño. Cada envase debe tener el nombre del medicamento, el nombre de la persona para quien ha sido recetado, en nombre del doctor que lo receta, y las instrucciones dadas por dicho medico. Todos los medicamentos en el almacenamiento central, tendrán que estar etiquetados y almacenados de acuerdo a las leyes Federales del Estado. La medicina debe estar guardada en el envase original en el que fue recibida. NINGUN MEDICAMENTO DEBE CAMBIARSE DE UN ENVASE A OTRO. La agencia debe ser responsable de asegurarse de que el registro de la persona que toma los medicamentos (guardados en un lugar central), contenga lo siguiente: El nombre de la persona a quien se le receto, el nombre del medicamento, la potencia y la cantidad del medicamento, la fecha en que se surtió, el numero de receta, y el nombre de la farmacia que surtió el medicamento.
4. Todos los medicamentos deben guardarse en un lugar central, en donde los niños no tengan acceso.
