

### Here is how it works:

- You purchase a gift card at face value (for example, a \$25 gift card sells for \$25)
- A percentage of that sale is donated back to the MSMHS PTO (for example, if you sell a \$25 gift card and the company donates 10%, you just raised \$2.50)

#### What do you need to do?

- Collect gift card orders from friends and relatives and collect payment for the cards ordered.
- Complete ONE **Summary Order Form** for all the orders you collect.
- Drop off Summary Order Form and check(s)/money order(s) to the Office at MSMHS (please put the MSMHS student's name on the memo line of the check.)

• Pick up gift cards when they arrive!
