INFORMATION REGARDING PURCHASING PARKING PERMITS

- IN ORDER TO OBTAIN A PARKING PERMIT YOU MUST COMPLETE THE APPLICATION (INCOMPLETE FORMS WILL BE RETURNED TO YOU). YOU MUST ALSO BRING A COPY OF YOUR VALID DRIVERS LICENSE AND CURRENT INSURANCE CARD. **WE WILL NOT ISSUE PERMITS WITHOUT ALL OF THESE!**
- YOU MUST PURCHASE ONE PERMIT **FOR EACH VEHICLE** YOU ARE DRIVING TO SCHOOL. (**NO EXCEPTIONS**). WE MUST REGISTER EACH VEHICLE THAT IS ON OUR CAMPUS TO ENSURE THE SAFETY OF OUR STUDENTS AND STAFF. THE COST FOR EACH PERMIT IS \$5.00.
- WE WILL **BEGIN ENFORCING** OUR PARKING PERMIT POLICY STARTING THE **WEDNESDAY, SEPTEMBER 1st**. THIS GIVES EACH STUDENT TWO WEEKS TO OBTAIN THEIR PERMIT(S).

HARDEE HIGH SCHOOL PARKING RULES & REGULATIONS

- ALL VEHICLES PARKED ON SCHOOL PROPERTY MUST BE REGISTERED WITH THE SCHOOL.
- **ALL PARKING PERMITS WILL BE DISPLAYED ON THE LOWER DRIVERS SIDE WINDSHIELD, AT THE BOTTOM OF THE WINDSHIELD & MUST BE CLEARLY VISIBLE.**
- THE SPEED LIMIT ON SCHOOL PROPERTY IS 10 MPH.
- ALL PARKING SPACES ARE FIRST COME FIRST SERVE.
- BY SIGNING THIS APPLICATION, STUDENTS AND PARENTS ARE GIVING SCHOOL OFFICIALS CONSENT TO SEARCH THEIR VEHICLE WHILE ON SCHOOL PROPERTY.
- **ALL VEHICLES MUST BE STREET LEGAL AND CONFORM TO ALL STATE LAWS AND YOU MUST POSSES A VALID OPERATORS LICENSE. ***A LEARNER’S PERMIT IS NOT ACCEPTABLE. *****
- A \$5.00 PERMIT FEE WILL BE PAID **PRIOR** TO RECEIVING THE PERMIT AND YOU MUST HAVE A **SEPARATE** PARKING PERMIT FOR EVERY VEHICLE YOU DRIVE TO SCHOOL.
- VIOLATING TRAFFIC LAWS OR SCHOOL RULES WILL RESULT IN SUSPENSION OF DRIVING PRIVILEGES **WITH NO REFUND.**
- **ALL STUDENT VEHICLES MUST BE PARKED INSIDE THE GATES.** THERE ARE NO EXCEPTIONS. NO PARKING ON COUNTY PROPERTY.
