**SUBJECT:** Title I - Parent's Right To Know Letter

*The "Parent's Right To Know" provisions under Section 1112(e)(1)(A) and (B) of Every Student Succeeds Act (ESSA) state that at the start of each school year, an LEA that receives Title I, Part A funds must notify parents of each student attending a Title I school that they may request and the LEA will provide, in a timely manner, information regarding the professional qualifications of their children's classroom teachers and, if applicable, the services provided by their paraprofessionals, as well as the paraprofessionals' qualifications.*

Attached is a copy of our district's parent notification letter in English and Spanish regarding the "Parent's Right to Know" provision. Please include this in your beginning of the year student packet. This should also be a part of new student packets throughout the year. It is to be signed by the parent and returned to the child's teacher. Please retain these letters for three years. Complete the attached attestation upon completing this requirement and send back the Federal Programs Office.

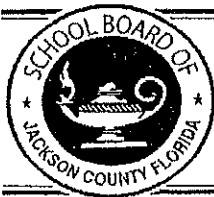

Queridos Padres,


