What is Title I?

Ithica Elementary is identified as a Title I school as part of the Every Student Succeeds Act (ESSA). Title I is designed to support State and local school reform efforts tied to the challenging State academic standards to improve teaching and learning for students. Title I programs must be based on effective means of improving student achievement and include strategies to support family engagement. All Title I schools must jointly develop with parents and family members a written parent and family engagement policy.

School Plan for Shared Student Achievement

What is it?

This is a plan that describes how Ithica Elementary will provide opportunities to improve family engagement to support student learning. Ithica Elementary values the contributions and involvement of parents and family members to establish an equal partnership for the common goal of improving student achievement. This plan describes the different ways that Ithica Elementary will support family engagement and how parents can help plan and participate in activities and events to promote student learning at school and at home.

How is it revised?

Ithica Elementary School invited all parents to attend our Annual School wide Title I Meeting as well as a Title I Parent and Stakeholder Input Meeting on April 18, 2019 and in July 9, 2019 to review and revise this parent and family engagement policy, as well as the schoolwide plan, our school-parent compact, and the 1% parental involvement budget. Additionally, parent input and comments regarding this plan are welcome during the school year through written feedback. The plan is posted on our school website for parents to view and submit feedback throughout the year. All parent feedback received during the year will be used to revise the plan for the next school year. We also distribute an annual survey online to ask parents for their suggestions on the plan and the use of funds for family engagement. Parents and family members can also give feedback during several parent meetings and activities during the school year.

Who is it for?

All students participating in the Title I, Part A program, and their families are encouraged and invited to fully participate in the opportunities described in this plan. Ithica Elementary will provide full opportunity for the participation of parents and family members with limited English, with disabilities, and of migratory children.

Where is it available?

At the beginning of the year, the plan is available for review in the front office and online at our school website. As a reminder, we will email the plan to all parents in July after an opportunity for feedback is given to all stakeholders. The final copy of the plan will be posted on the school website and social media. Parents can also retrieve a copy of the plan in the Parent Resource Center and our front office.

2019-2020 District Goals

1. The percentage of students scoring at Proficient or above on the Georgia Milestones (GMAS) English Language Arts End of Grade Assessment will increase by three percentage points.
2. The percentage of students scoring at Proficient or above on the Georgia Milestones (GMAS) Mathematics End of Grade Assessment will increase by three percentage points.

2019-2020 School Goals

- Meet or exceed state average on Georgia Milestones state assessment in all content areas.
- The percentage of students scoring at or above the lexile band on the GMAS will increase by three percentage points.

School-Parent Compacts

As part of this plan, Ithica Elementary and our families will develop a school-parent compact, which is an agreement that parents, teachers, and students will develop that explains how parents and teachers will work together to make sure all our students reach grade-level standards. The compacts will be reviewed and updated annually based on feedback from parents, students, and teachers during annual input meetings. The school-parent compacts are also sent home with each student and a school-parent compact agreement is signed by student and parents.

History Night– March 9, 2020

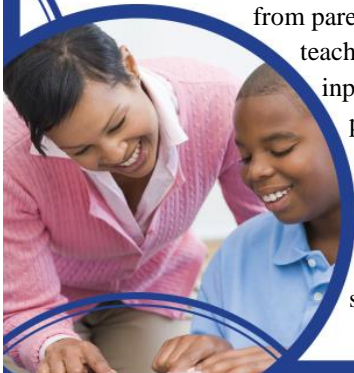
Come and meet important historical figures as they share facts about their lives.

Ithica Elementary will take the following measures to promote and support parents and family members as an important foundation of the school in order to strengthen the school and reach our school goals. We will:
