Welcome parents and community members! We are glad to welcome you to our school's Title 1 Annual Parent Meeting. This evening, we will be reviewing and discussing our school's Title 1 program.
We will cover the following items that are important to you as parents:

What is a Title 1 school?

Title 1 of the Elementary and Secondary Education Act (ESEA) provides financial assistance to state and local education agencies to meet the needs of at-risk children. The goal of Title 1 is to provide instructional services and activities which support students in meeting the state's challenging performance standards.

Title 1 Money

How does our school spend Title 1 money and how does our school participate in the Title 1 program? Title 1 programs generally offer:

- Smaller classes or special instructional spaces
- Additional teachers and paraprofessionals
- Opportunities for professional development for school staff
- A variety of supplementary teaching methods
- An individualized program for students
- Additional teaching materials which supplement their regular instruction
- Technology
- Parent involvement in children's education

At Graysville Elementary we use our Title 1 money to:

- Provide learning materials through technology resources
- Provide parent involvement activities and services
- Employ the services of an academic coach and reading and math interventionist
- Employ the services of an intervention paraprofessional

Title 1 and Parent Involvement

What is required by law for parent involvement?

School systems must ensure that strong strategies are in place to:

Is my child's teacher highly qualified?

As a Title 1 school, we must meet federal regulations related to teacher qualifications as defined by ESEA. These regulations allow you to learn more about your child's teachers' training and credentials. We are happy to provide this information to you. At any time you may ask:

- Whether the teacher met state qualifications and certification requirements for the grade level and subject he/she is teaching
- Whether the teacher received an emergency or conditional certificate through which state qualifications were waived
- What undergraduate or graduate degrees the teacher holds, including graduate certificates and additional degrees, and major(s) or area(s) of concentration
- You may also ask whether your child received help from a paraprofessional, and information about the paraprofessional's qualifications.

Title 1 Schoolwide Requirements and Goals

GES is a Title 1 schoolwide program. What are our school's Title 1 schoolwide requirements?

The purpose of schoolwide Title 1 programs is to improve the entire educational program in a school. This should result in improving the academic achievement of all students, particularly the lowest achieving students. See the handout on Schoolwide Components. We always want your input on how GES can carry out the schoolwide program.


What are our schoolwide goals?

- Increase the percentage of students who score in the developing learner or better categories in ELA by five percentage points on the GA Milestones.
- Increase the percentage of students who meet the grade level stretch band (Lexile score) by five percentage points on the GA Milestones

What programs/supports are in place to help my child?

- Reading and math interventionist
- Computer and technology software to support reading and math instruction
- Reading intervention paraprofessional

*Student progress will be monitored throughout the school year. Interventions will be provided for students who do not master all the elements of the standard during the school day and after school.



Designation Status

What is our school's Designation Status and what does this status mean?

Under the 2015 renewal of Georgia's ESEA Flexibility Waiver, certain Title 1 schools continue to be designated as Reward, Priority, or Focus Schools. I am very proud to tell you that Graysville Elementary School has been given a designation status of Reward School this year, which means we are a Title 1 school that is continuing to provide a quality education to all of our students. Based on the definition of Reward Schools found in the ESEA Flexibility Waiver, the High-Progress Reward Schools are among the highest 10 percent for the Title 1 schools in the state. Calculations to identify these schools are based on the achievement of the "all students" group in terms of proficiency, on the statewide assessments that are part of the SEA's differentiated recognition, accountability, and support system.

The major strengths we found in our program were that 92% of all students in grades 3, 4, and 5 passed the mathematics portion of the test. In 3rd and 5th grades, 84% of students passed English Language Arts. The major needs we discovered were in 4th grade English Language Arts, where only 71% of students passed and only 31% of SWD passed. Please refer to our Schoolwide Plan for more details.

We are very excited to see great results and are very proud of our students and our teachers. We appreciate the support that you have given to our school Our goal is to make sure that all students are successful and working on grade level as quickly as possible.

What about Curriculum and Tests?

Catoosa County Schools use the state adopted standards as the basis of curriculum. Currently, the adopted curriculum is the Georgia Standards of Excellence (GSE). These standards provide clear expectations for instruction, assessment, and student work. Teachers are encouraged to use instructional frameworks which include an opening, work session, and closing for delivery of instruction. Pacing guides and curriculum units called "frameworks" are some of the resources used to support the implementation of the Georgia Standards of Excellence. These standards provide a consistent framework to prepare students for success in college and/or the 21st century workplace. Resources can be found online at www.georigastandards.org.

Students in grades three through twelve take the Georgia Milestones assessment. Instruction is centered on the Georgia Standards of Excellence. At the Elementary level, third and fourth grade students take ELA and Math. Fifth grade students take ELA, Math, Science, and Social Studies.

Students will also take a reading and math benchmark test three (3) times a year using the STAR programs.

The purposes of the Georgia Student Assessment Program are to measure student achievement relative to the state-mandated content standards, to identify students failing to achieve mastery of content, to provide teachers with diagnostic information, and to assist school systems in identifying strengths and weaknesses in order to establish priorities in planning educational programs. The assessment program includes customized criterion-referenced tests at the elementary, middle, and high school levels. See the Student Testing in Georgia handout.

Georgia Milestones relies on the Georgia Student Growth Model (GSGM) initiative designed to provide students, parents, educators, and the public with important information on student progress. Academic achievement only tells part of the story. The addition of student growth tells a more complete story about the academic performance of students. Now we not only know where students end up, but we also know how much progress they made to get there. This is an exciting time for students and their parents!
