PARENTAL CONSENT FOR PARTICIPATION

I understand that all information provided on the Athlete Information Form is strictly confidential for the use of physicians, athletic trainers, and appropriate school personnel who will be directly involved with my child. I also understand that Decatur County School's Certified Athletic Trainer will at times have student apprentices and student athletic trainers working in a teaching environment and acknowledge that strict medical confidentiality will be executed with all injuries and treatment to my child. I hereby give my consent for the above student to represent his or her school in the athletic activities indicated above. I consent for the student to undergo the pre-participation medical examination by the physicians and medical assistants recommended by the Decatur County Board of Education and agree to abide with their recommendations regarding participation in these events. The parents further understand that the pre-participation medical examination is a screening examination and is not intended to identify all problems that could cause student death during vigorous exercise. The parents hold harmless the physicians, athletic trainers, and other personnel in the pre-participation examination, including Memorial Hospital and Decatur County Board of Education. I also give my consent for the student to accompany the school team on local or out of town trips. I also give my consent for school personnel to call for assistance and/or take my child to a doctor/emergency room if treatment appears to be in order. In the case I cannot be notified of the injury to give parental consent, I authorize the school personnel or certified athletic trainer to sign the necessary consent forms so that my child can receive medical treatment. I also give permission for the Decatur County's School's Certified Athletic Trainer to provide therapeutic modalities and rehabilitative exercises to my child's injury in accordance to Georgia's Athletic Trainer's practice act of 1992. **I also agree and understand that I am responsible for providing medical insurance for my child and I am responsible for all medical bills which arise from injury to my child during school sponsored athletic participation.** The Decatur County Board of Education and the represented school is in no way responsible for the medical bills which arise.

The parents understand that the risk of injury is assumed by the student and parents when they are executing this form. However, in the event physicians, certified athletic trainers, nurses, or other persons trained in the rendering of first aid are available, as volunteers or otherwise, and render first aid to any student injured during the course of any such activities or travel, then the parents do hereby release and forever discharge such persons and the Decatur County Board of Education from any liability arising out of any first aid or immediate treatment of injuries.
