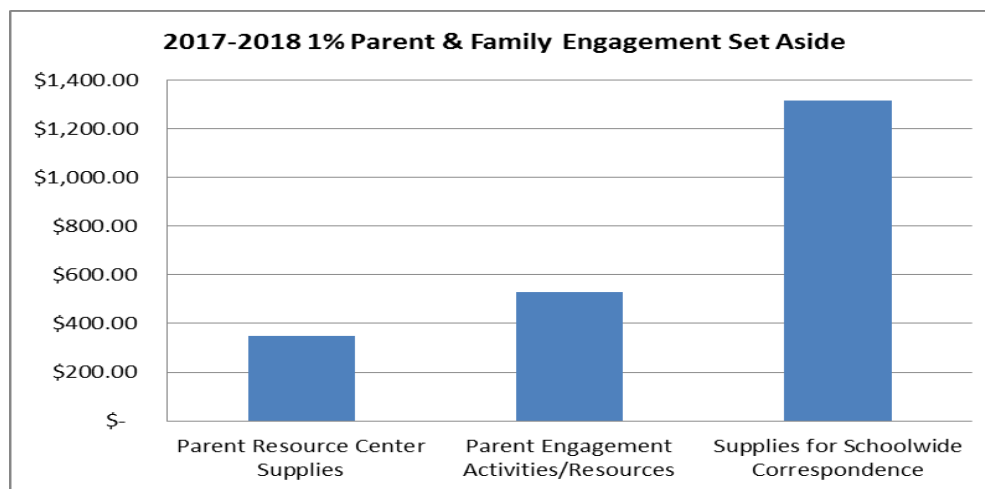
**Parent and Family Engagement Budget Survey**
