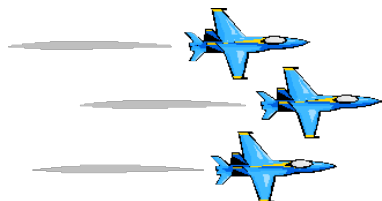


LINDSEY ELEMENTARY SCHOOL

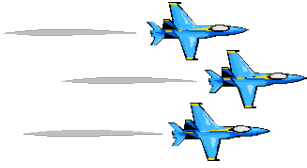
Long Range

Goal 2: *By the end of the 2017-2018, we will increase the percentage of students' performance proficiency in mathematics by 3% as measured by the state assessment and county benchmarks.*
