**What is Title 1?**

**Lamar County Primary School is identified as a Title 1 school as part of the Elementary and Secondary Education Act of 1965 (ESEA). Title 1 is designed to support State and local school reform efforts tied to challenging state academics standards in order to reinforce and enhance efforts to improve teaching and learning for students. Title 1 programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title 1 schools must jointly develop with all parents a written parental involvement policy.**

**What is it?** This is a plan that describes how Lamar County Primary School (LCPS) will provide opportunities to improve parent engagement to support student learning. **How is it developed?** Lamar County Primary School welcomes parent input and comments at any time regarding the parental involvement plan. LCPS will provide full opportunity for the participation of parents with limited English, parents with disabilities and parents of migratory children.

**Where is it available?** At the beginning of the year, this plan will be distributed in multiple ways to all parents and the community. Each parent/student will receive a hard copy.
