Title I is a part of the Elementary Secondary Education Act (ESEA) and the new Every Student Succeeds Act (ESSA). This Act provides federal funds through the Georgia Department of Education to districts with high numbers or percentages of poor children to help ensure that all children meet challenging State academic content and performance standards. Title I funds allow schools to offer a variety of services which may include additional teachers and support staff, extra time for instruction, training on a variety of instructional methods, and instructional materials.

Title I

Qualifications: Schools qualify for funds based on economic need. Pierce County Schools are School-wide Title I programs.

In order to meet the requirements of a school-wide program, each school must develop a plan that includes:

- * Areas of need based on test results and surveys
- * Proven school-wide reform strategies
- * Instruction by highly qualified teachers
- * Professional learning for staff
- * Meaningful parent involvement strategies
- * Transition plans for elementary, middle school, high school and college readiness
- * Measures to include teachers in the decisions regarding the use of assessment to guide instruction
- * Coordination and integration of federal, state, and local services and programs
- * Strategies to meet the needs of at-risk students in a timely manner
- * Description of how individual student assessment results and what they mean in relation to student learning are communicated to parents
- * Procedures for collecting and interpreting student achievement data
- * Procedures to ensure achievement data is valid and reliable
- * Procedures for reporting student achievement data to the public
- * Procedures for reviewing the plan annually
- * Methods for including all stakeholders (teachers, parents, students, administrators, and the community) in the development of the plan
- * Method(s) for making the plan available to the public for review
- * Efforts to translate the plan, to the extent feasible

Parents Have the Right...

- *to know the professional qualifications of their child's teacher(s) including the degrees and certifications held, and whether the teacher is certified in the respective area of instruction.
- *to know the school improvement status of the school.
- *to know the level of achievement of their child in each area of the state assessment.
- *to know if their child has been assigned, or has been taught for at least four consecutive weeks, by a teacher who does not meet the highly qualified definition.
- *to be involved in the planning and implementation of the parent involvement program in their school.
