**PART I: GENERAL EXPECTATIONS**

**School: Scott Elementary District/LEA: Thomasville City Schools**

1. **Scott Elementary School** will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs including involvement in the decisions regarding how funds for parental involvement will be used.

- A. Parents are invited to attend the beginning of the school year Title I Meeting to receive information about Scott Elementary School.
- B. Parents will be notified of the meeting via Power Announcement, Facebook Page, flyers, school website, and posted on the school marquee. Throughout the school year, parent representatives are invited to School Improvement Team Meetings/ Parent Engagement Planning Committee meetings where Title I issues are discussed.
- C. The school’s leadership team will conduct a needs assessment each year to determine focused areas to be addressed for continued success of its educational program. Parents will be given the opportunity to provide feedback and make recommendations for improvement through letters sent home, school website, and emails sent out to parents by the principal.
- D. The school will jointly develop with parent advisory and school council a Parent Involvement Policy that the school and parents of students enrolled at Scott can agree on.
- E. Drafts of School-wide Title I plans will be shared with parents to review and provide feedback.
- F. The school will facilitate and implement the Parent Involvement Policy. Copies of the Policy will be distributed to parents of students enrolled at Scott and placed on the school’s website.

G. The school will collaborate with parents to draft and adopt the school's home-school compact as a component of its Parent Involvement Policy. The compact outlines the responsibilities of the student, teacher, parent, and principal. It will be sent home at the same time as the Parent Involvement Policy.

2. **Scott Elementary School** will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend, to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements and the school parental involvement policy, the school-wide plan, and the school-parent compact.

3. **Scott Elementary School** will take the following actions to offer a flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, child care or conference call, as such services relate to parental involvement.

· Family nights, grade level meetings, PTO meetings, and school wide events will be held at different times and days of the week to accommodate working parents with attendance. Teachers are encouraged to offer parents conferences at flexible times to accommodate parents' working schedules. Childcare may be provided, when necessary. Transportation will be made for meeting with parents who cannot arrange transportation to the school, upon request.

4. **Scott Elementary School** will take the following actions to provide parents of participating children the following:

- Description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the proficiency levels students are expected to meet;

A. **Scott Elementary School** will provide assistance to parents of participating children, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph –

- the State’s academic content standards;
- the State’s student academic achievement standards;
- the State and local academic assessments including alternate assessments;
- the requirements of Part A;
- how to monitor their child’s progress, and
- how to work with educators

Parent University: Parent University is a community collaborative that supports families. This initiative encourages parent involvement and participation in the education of our community’s children and youth. Its objective is to maximize student learning by creating a strong bridge between the community and the school.

- Enable "parents" to teach each other.
- Train "informed parents" to work together with schools to create paths for student success.
- Provide support, guidance and nurturing to assure the realization of family success.

B. **Scott Elementary School** will provide materials and training to help parents to work with their child to improve their child’s achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by conducting topics from Parent University that will educate and train parents on topics in need of discussing as recommended by parents, Leadership Team, and from parent surveys.

C. **Scott Elementary School** will provide training to educate the teachers, pupil services personnel, principal, and other staff in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs, and build ties between parents and the school, by collaborating to identify effective strategies to strengthen lines of communication between the home and the school. All parents will be provided with grade level conferences and/or meetings to accommodate their child's needs. ELL parents will be contacted via phone using parent-friendly language and invited to the school in an effort to keep them informed and involved. Newsletters will be translated, as appropriate. An interpreter will also be available, as appropriate. Parents of IEP students will always be offered a handbook of their rights and given the opportunity to ask questions about the handbook.

F. **Scott Elementary School** will provide other reasonable support for parental involvement activities under section 1118 as parents may request.
