Jackson County High School is a rural school located in Southeastern Kentucky. McKee is the county seat. The biggest change that has occurred within the last three years was the move to the new high school, which occurred at the beginning of the 2012-13 school year. JCHS currently serves 596 students in grades 9-12. Over 99 percent of the student population is white. This is also true of the staff of the school and the community as a whole. The biggest challenge faced by the school is the socioeconomic status of the county. Thirty percent of the population lives below the poverty line. Because the socioeconomic status is so low, JCHS is a Title 1 school. All of our students receive free meals.

Jackson County High School's mission is to ensure that all graduating students are college or career ready and become productive members of society. Finally, the overall attendance rate has increased dramatically. There are more students attending school. There are areas for improvement. Finally, the school needs to show that students are achieving at high levels through the state assessments, such as the EOC exams, on-demand writing and program reviews.

# **Data Analysis**

# What question(s) are you trying to answer with the data and information provided to you? What does the data/information tell you? What does the data/information not tell you?

The school is trying to answer which instructional areas are doing well and which ones are in need of improvement. What is working well and what isn't? Are the needs of the students and staff being met? The Unbridled Learning Achievement score was much higher than the actual target. The school exceeded its target in the following academic areas: social studies (all students, free/reduced and special education); math (all students, free/reduced and special education); reading and math combined (all students and free/reduced); and writing (special education). There was not a special education score for reading and math combined. In the non-academic data, the school achieved progress in attendance rate, retention rate and transition rate. The percentage of students who were college and/or career ready increased. JCHS did not meet its target in the following areas: writing (all students, free/reduced); science (all students, free/reduced, special education); and reading (all students, free/reduced, special education). In the non-academic areas, the school's drop out rate increased. The PLAN score for the 2012-13 school year was the highest it had ever been. The 2012-13 ACT was the second highest it had been. The TELL survey shows that overall, most of the staff at JCHS feel as if their needs are being met to be successful teachers, but they feel they need more professional development in certain areas, such as differentiation. They would also like to be more involved in planning the school budget. The data doesn't provide the reasoning for some areas to achieve the wanted success. For example, what were the major causes of the school's dropout rate increasing?

# **Areas of Strengths**

# What were the areas of strength you noted? What actions are you implementing to sustain the areas of strength? What is there cause to celebrate?

The school's overall Unbridled Learning accountability score increased by over ten points, which was in the top twenty percent of the state for improvement. This was definitely a reason to celebrate. The achievement goals were met or improved in the following areas: attendance rate, retention rate, transition rate, social studies, math and the combined reading and math score. The 2012-13 PLAN score was the highest it has ever been. The 2012-13 ACT score was the second highest ever. The number of students being college and/or career ready increased. In order to continue that success, the school will keep using the full inclusion model for special education students. The school also switched to a tradition six period schedule so students will have most of their subjects year round. Teachers will continue to attend LTF training and implement what they learn into their lessons. Most teachers will be completing their third year in 2014. The school will continue to emphasize the use of ACT and EOC like tests. All students are also required to declare a career path by the end of the second year. The principal will also keep enforcing the attendance policy that was instituted a couple of years ago.

# **Opportunities for Improvement**

#### What were areas in need of improvement? What plans are you making to improve the areas of need?

JCHS needs to improve in the following areas: dropout rate; writing (all students and free/reduced); science (all students, free/reduced, special education); and reading (all students, free/reduced, special education). The KOSSA pass rate was very poor. The drop in reading scores was the most surprising because those scores are usually some of the highest. To help the dropout rate, the school is going to continue trying to meet the needs of all kids by attaching them to a career pathway that peaks their interest. Their ILP teacher will be vital to this endeavor. To increase writing, the school will offer professional development to all staff on the writing process and the LDC modules. To improve the science scores, teachers will implement more LTF lessons and provide more lab experiences. The teachers will also incorporate the new science standards, which are much more inquiry based. To improve KOSSA scores, CTE teachers will be involved in professional development to evaluate their program and make sure their programs are aligned to the state standards. Finally, to improve the reading scores, the school will offer professional development on reading strategies to all teachers. The PD will focus on the type of questions that students should be able to answer about any type of passage that they read.

# Conclusion

#### Reflect on your answers provided in the previous sections. What are your next steps in addressing areas of concern?

The next steps will be trying to provide the needed professional development as soon as possible. Most of this will take place in the school's professional learning communities. The school will also keep track of courses that students have completed in their career pathway and provide guidance for them to finish the ones they have chosen. For students who haven't met benchmark on the ACT, continue identifying them and provide interventions so they can complete the COMPASS or KYOTE assessment. Teachers will also use ThinkLink scores to identify areas of concern and then make instructional adjustments to address those areas. They will also use relevant formative and summative assessments to gauge the impact their instruction is having upon student achievement. The CTE department will also be evaluating their program to see what they can do to improve their KOSSA pass rate.
