**What To Bring:**  
 Campers should bring with them the following items:

- Alarm clock
- Basketball sneakers
- Bedding and pillow
- Towels and washcloths
- Soap and hygiene products
- Multiple t-shirts
- Sweat socks
- Multiple pairs of gym shorts
- Windbreaker/sweat suit

**Medical:** A certified athletic trainer is on duty at all times. A doctor is on call, and hospitals and student health facilities are readily accessible. Because of the rigorous daily schedule, all campers should arrive at camp in peak physical condition. Every effort is made to ensure each camper's safety through training of staff, constant inspection of equipment and careful instruction of campers. Please be certain to sign the indemnification and medical treatment authorization form on the application. No other medical forms are necessary.

**Discipline:** Any serious violations of camp regulations will result in the immediate dismissal of the offending camper. NO REFUND OF TUITION WILL BE GIVEN IN THE EVENT A CAMPER IS DISMISSED FOR DISCIPLINARY REASONS.

**Mail Delivery And Phone Calls:** Daily mail delivery and pick-up is made at camp. When writing to a camper, address all mail to the camper, c/o Mizzou Basketball Camp, 230 Mizzou Arena, Columbia, MO 65211. The camp does not allow unnecessary phone calls, either incoming or outgoing because of the interruption to the schedule and the effect on the camper's morale. In case of emergency, the camper's guardians will be notified immediately.

**Cancellations:** After June 1, refunds less the \$10 administration fee, will be made only for medical reasons when accompanied by a physician's letter. Should the camper leave during the week for medical reasons the refund will be prorated. No refunds will be made to campers who voluntarily leave camp during the week. Any camper leaving for injury/illness must be seen by a camp trainer before leaving camp.

**Location:** The Mizzou Basketball Camp is located on the beautiful campus of the University of Missouri-Columbia. Camp activities will take place in the new Mizzou Arena, located on the corner of Mick Deaver Drive and Champions Drive.

**Registration And Pick-Up:** Registration will take place on the first day of camp at the Main Concourse level of the Mizzou Arena.

**Accommodations:** All campers will be housed two to a room in a dormitory on campus. Campers are under the constant supervision of coaches who stay in the dorms as well. You will need to provide your own bedding (twin size), pillow and towels. All dormitories are air-conditioned.

**Roommates:** If you have a roommate preference, please be sure to denote that on your application. Include the name of the person with whom you wish to share a dorm room, as roommate assignments will be made upon receipt of your application and prior to registration day. We cannot change room assignments on the day of registration.

**Meals:** Each meal is planned carefully by the camp nutritionist and consists of an abundance of wholesome and well-balanced foods for active campers. Three full meals featuring an all-you-can-eat selection of entrees and other foods, in addition to unlimited beverages, will be served daily in an air-conditioned dining hall.
