- Copy of college transcript (if applicable)
- Copy of medical school acceptance letter (if applicable) for the Glenn Davis Gray Memorial Scholarship
- Applicant's supporting statement (must be typewritten)
Explain your objectives for the future, both educational and personal, and give details concerning the degree of your need for financial assistance. Any further information (family or personal crisis, hardship, etc.) that you feel would be of interest to the scholarship award committee in their consideration of the merit of your application would be appreciated.
- Verification of parental income may be requested

Three (3) letters of recommendation (two academic and one personal/civic) must be sent directly to the Junior Auxiliary from the individual writing the recommendation.
