### **Covid-19: Social Distancing for School Registration**

**With the continuous spread of the COVID-19 also known as the Coronavirus and the recent reports of rising cases in Mississippi, coupled with students and staff being out since Spring Break, many parents, staff and stakeholders are understandably concerned about next steps for the Sunflower County Consolidated School District as it relates to prevention. With this being said, registration will be a little different this year. Parents without internet will be able to have access to computers at school but with the following restrictions.**

- Must wear mask to enter the building**
- Must make an appointment before coming to school (to make sure we are six feet apart)**
- Must come without children (ten people or less in the building at all times)**
- Only one (1) parent/guardian will be able to register per child. ( we must practice social distance**
- We, at RMS, will only allow four (4) people in the library at a time for registration (must scheduled an appointment)**

## Compulsory School Attendance

### Referral Process

- Mississippi law requires all individuals between the ages of six (6) and seventeen (17) to enroll in and attend school. This law also applies to all five-year old students enrolled in a full-time public kindergarten program.
- Student misses five (5) cumulative unexcused days. Report to School Attendance Officer, who will attempt to secure attendance with a letter, home visit, and or letter.
- Student misses twelve (12) cumulative unexcused days. Report to School Attendance Officer, will attempt with to secure attendance with a letter, home visit, and or letter.
- Once ALL attempts have been made, the School Attendance Officer may file a petition in youth, city, county, or justice court.
- Suspensions are unexcused absences and must be reported as they occur.
