

Student Check Outs

Parents/Students will be allowed to check out up to 30 minutes before the end of the school day. Thereafter, the student must remain until the bell rings at the end of the school day.

Electronic/Cell Phone Policy

Teachers will not allow students to use their cell phones in class

School Policy: Not visible and turned off

Students may not charge their phones in your classroom

Teacher will not hold phones and give them back to the student

"If a student needs to contact a parent, they will need to go the office and use office phone".

***Administrator or Administrator Designee confiscates phone for parent pick up.**

*Refusing to give cell phone to administrator designee will result in disciplinary actions

Cell Phone School-wide Policy

Cell Phone Violation	
	*Parents/guardians may not come earlier than the end of the school day to retrieve phones. This includes early release students.
1 st Offense	Administrator confiscates phone for parent pick up at the end of the school day
2 nd Offense	Administrator confiscates phone for parent pick up after 5 school days
3 rd Offense	Administrator confiscates phones for parent pick up after 10 school days
4 th Offense	Administrator confiscates phone for the remainder of the school year.
	<u>Note:</u> (Refusing to give a cell phone to administration is an automatic 10 day OSS)

Food, Flower, Balloon Delivery During The School Day

FLOWER AND BALLOON DELIVERY

There will be no flower or balloon delivery during the school day.

Any food for flower/balloons delivered will be returned to the person or business who brought it. Parents, guardians, other students, friends, or delivery services may not drop food off directly to students neither will staff accept food and flowers on behalf of the student.

Students are not allowed to have lunches delivered to them on campus or dropped off in front of the cafeteria or any other location.

- **Students may not bring food from restaurants in their original containers.**

In addition to school meals, students may have access to foods/beverages in school stores, through fundraisers or other sources. These foods are not offered as part of the School Nutrition Program. These foods are called competitive foods. Competitive foods are those foods/beverages sold or offered to students in competition with school meals. If the sale or availability of foods/beverages competes with a student's ability and/or willingness to receive or purchase a school meal, it competes. Federal regulations, state statutes, and local Board policy prohibit competitive foods...

10 Minute Policy

Students may not be in the halls for any reason the first 10 minutes or last minutes of class.

Dress Code

1st Offense: Student must report to ISS with an opportunity to change clothes, receive tie cord, or have a parent bring appropriate clothing no later than 9 a.m.

2nd Offense: Student must report to ISS with an opportunity to change clothes, receive a tie cord, or have a parent bring appropriate clothing no later than 9 a.m. *The ISS Coordinator will verify student has on appropriate clothing and will send an email to the appropriate teachers of dress code violation & will give student a note to class.*

3rd Offense: Student will remain in ISS for the entire school day with no opportunity to change or have clothing brought by parent.
