

White Oak High School Campus Parking Regulations

(Updated- 11/20/16)



1. A student must be eligible to purchase a parking pass (\$25.00) after all current and prior fees are paid (including textbooks, media, athletic, 1:1, cafeteria, band, clubs, etc.).
2. Parking pass eligibility is determined by presenting the following information to the office:
 - signed and dated Campus Parking Regulations form,
 - a valid NC Driver's license,
 - proof of insurance, and
 - a valid Vehicle Registration form in the student's name or the name of a parent, guardian, or other person that has presented a notarized letter giving the student permission to drive the vehicle.
3. The parking pass must be purchased prior to parking a vehicle on campus.
4. The parking pass must be hung on the rear view mirror with parking spot number facing out. The pass must be visible. **Permits are non-transferrable.**
5. The parking pass will be assigned to a reserved number in a designated parking lot. Students may not park on the grass, a sidewalk, any road area, or any area NOT assigned. Vehicles parked in the wrong space or in an unauthorized area may receive a citation.
6. Vehicles may NOT be left on campus overnight unless prior permission has been granted.
7. The speed limit on campus is NOT to exceed 10 MPH. Drivers and passengers should wear their seat belt. Citations may be issued for a speeding violation or a seat belt violation.
8. Vehicles should be secured at all times. WOHS isn't responsible for lost/stolen items.
9. Students must enter the building upon arriving on campus. Loitering in vehicles or the parking lot may result in a citation.
10. To return to a vehicle during the school day, students must first receive office permission.
11. Vehicles parked on campus are *subject to search* without consent or notification. (BOE policy 4342). For illegal items found, the registered driver (and if confirmed, riders) will be culpable. They are considered to have knowledge, dominion and control over the items.
12. Students may NOT leave campus for lunch.
13. Students are NOT permitted to PASS another vehicle in the parking lot or while entering or leaving the campus. Failure to yield as directed will result in permit revocation.
14. Students with attendance issues, habitual tardiness, and /or discipline issues may have their parking privileges suspended or revoked until such issues are resolved.
15. Cars illegally parked or without a paid permit will be towed at the owner's expense.

Violations of the above regulations will result in temporary or permanent revocation of privileges without reimbursement and tickets/citations.

WOHS is not responsible for damages to or theft from vehicles. Parking a vehicle on campus is a privilege. Students may lose the right to park on campus for a specified period of time or indefinitely for any infraction of these rules or for the improper operation of the vehicle on the school's campus. School disciplinary actions may include the loss of campus parking privileges for a specified time or indefinitely. Students who insist on parking a vehicle on campus following the loss of parking privileges can expect the vehicle to be removed from campus at the owner's expense.
