

**CONTRACT FOR PRESCHOOL EDUCATIONAL SERVICES 2019-2020**

**W I T N E S S E T H:**

WHEREAS, \_\_\_\_\_ (Parent(s)/Guardian(s)), has made application for admission of \_\_\_\_\_ Child(ren) to the Califon Public School on a tuition basis; and

WHEREAS, the Board through its administration, has reviewed the Child(ren's) academic and confidential pupil files, and has determined that Child(ren) is(are) eligible for admission to the Califon Public School.

NOW THEREFORE, be it agreed as follows:

1. Child(ren) shall be admitted to the Califon Public School as a preschool tuition pupil(s) for the 2019-2020 academic year.
2. The preschool shall operate only on those days that the K-8 pupils attend school and only during the hours of 8:30 a.m. to 11:30 a.m.
3. Child(ren) shall attend preschool the following number of days per week (check one):

4. Parent(s)/Guardian(s) shall pay the Board tuition by check or money order as follows (check one):

5. Preschool tuition covers in-district curricular programs and activities.
6. The Parent(s)/Guardian(s) of the Child(ren) is(are) solely responsible for making all transportation arrangements and paying all transportation costs to and from Califon Public School.
7. The Parent(s)/Guardian(s) and Child(ren) will comply with all school rules, regulations and requirements. In the event the Parent(s)/Guardian(s) or Child(ren) fail(s) to comply, the Board reserves the right to terminate this Agreement and to suspend all services provided hereunder. In the event of such termination, there shall be no refund of tuition already paid.
8. In the event a Child Study Team evaluation reveals a need for placement outside the Califon School District, or such an out-of-district placement is deemed appropriate for any reason whatsoever, this contract will be terminated as this contract applies only to services available directly with the Califon Public School.
9. In the event that tuition payments are not made as set forth in paragraph 4, the Board reserves the right to pursue all legal remedies available to it including, but not limited to, immediate suspension of all services to the Child(ren) and institution of an action for damages, including attorneys' fees and costs, in a court of competent jurisdiction.
10. This Agreement may be terminated by the Board or the Parent(s)/Guardian(s) upon two (2) weeks' advance written notice.
