Students will discover the benefits of embracing their own special qualities. • Students will self-select and read a variety of texts voluntarily • Students will have opportunities for practice in reading independently using the Literature Circles model • Students will draft, revise, and edit writing using the Writing Process model, employing the 6 Traits of Effective Writing
