The Pyramid Lake Jr/Sr High School had their annual audit completed and accepted by the School Board of Education during their December 2014 meeting. Herein is the Management's Discussion and Analysis which will provide an overview of our annual audit at June 30, 2014. This year the High School did not have any audit findings and received an unmodified or unqualified opinion from the auditing firm. PYRAMID LAKE JUNIOR/SENIOR HIGH SCHOOL MANAGEMENT'S DISCUSSION AND ANALYSIS FOR THE YEAR ENDED JUNE 30, 2014

This section of the Pyramid Lake Junior/Senior High School's (the School) financial report presents management's narrative overview and analysis of the financial activities of the School for the fiscal year ending June 30, 2014. Please read it in conjunction with the School's financial statements, which follow this section.

Overview of Financial Statements

This annual report consists of a series of financial statements. The statement of net position and the statement of activities provide information about the activities of the School as a whole and provide both long-term and short-term information about the School's overall financial status. Fund financial statements report School operations in more detail than the government-wide statements by providing information about the School's most significant funds. Fund financial statements include:

- Governmental fund financial statements that indicate how School services such as education and facilities were financed in the short-term and what remains for future spending.
- Fiduciary fund is used to account for the School's employee's retirement trust.

The financial statements also include notes that explain the information in the financial statements and provide more detail. The notes are followed by a section of supplemental information that presents combining financial statements for the School's non-major governmental funds. The supplemental information is then followed by the information required for OMB Circular A-133 single audits.

Government-Wide Financial Statements

One of the most important questions asked about the School's finances may be, "Is the School as a whole, better off or worse off, as a result of the year's activities." The statement of net position and the statement of activities report information about the School as a whole and about its activities in such a way that helps answer this question. These statements include all assets and liabilities using the accrual basis of accounting, which is similar to the accounting used by most private-sector companies. All of the current year's revenues and expenses are taken into account regardless of when cash is received or paid.

These two statements report the School's net position and changes in them. Net position, the difference between assets and liabilities, is one way to measure financial position, or health. Over time, increases or decreases in net position are one indicator of whether financial stability is improving or deteriorating. Other non-financial factors, however, such as changes in the scope or size of operations, and other potential influences from tribal, state, or federal agencies, should be considered in addition to net position in measuring financial stability.

Fund Financial Statements

The fund financial statements provide detailed information about the most significant funds – not the School as a whole. Separate funds are established to help control and manage revenues and expenditures for particular purposes or to show that it is meeting legal responsibilities for using certain grant money. Additionally, separate funds are maintained to guarantee against the possibility of co-mingling funds. The School has two types of funds:

- Governmental Funds Most of the School's basic services are reported in governmental funds. Governmental funds focus on how cash and other financial assets flow in and out, and the balances that are left at year-end available for future spending. These funds are reported using an accounting method called modified accrual accounting, which measures cash and all other financial assets that can readily be converted to cash. Consequently, the governmental fund financial statements provide a detailed short-term view that helps determine whether there are more or fewer financial resources that can be spent in the near future to finance School programs. Because this information does not encompass the additional long-term focus of the government-wide financial statements, additional information is provided on a subsequent page that explains the relationship (or differences) between governmental activities and balances reported in the statement of net position and statement of activities and governmental fund financial statements.
- Fiduciary Funds Used to account for assets held by a governmental unit in a trustee capacity or as an agent for individuals, private organizations, or other governmental units. The School has one fiduciary fund, a retirement trust fund used to account for employee benefits. The fiduciary fund is not included in the government-wide financial statements.

Financial Highlights

- The School received \$3,130,851 in Federal and State funding for School operations; this
 is a decrease of \$170,567 from the prior year. Deferred inflows of resources (deferred
 revenue) were \$763,427 at June 30, 2014, which includes \$3,541 for various classes.
 The year-end deferred revenue is a decrease of \$355,369 from the prior year.
- The Money Market fund balance at June 30, 2014, was \$1,028,492; total interest earned during the fiscal year was \$3,888. This is a decrease from the prior year due to lower interest earnings and a decreased amount in the fund.
- Total expense for the fiscal year was \$3,224,764; this is a decrease of \$113,709 from the prior year.
- The combined ending fund balance for all governmental funds at June 30, 2014, was \$87,791; this is a decrease of \$16,790 from the prior year.

Fiduciary Fund

The School maintains a retirement plan for eligible employees. The Administrator of the Plan is Qualified Plan Consultants; the investment pool is held in trust by Invesco Investment Services, Inc. Quarterly and annual reports are provided to participating employees. The fiduciary fund's net position at June 30, 2014, was \$619,646. This is an increase of \$96,705 from the prior year's net position of \$522,941.

Capital Assets

As of June 30, 2014, the School had \$90,503, net of depreciation, invested in equipment and vehicles. See the notes to the basic financial statements for more details about capital asset activity.

Economic Factors

The School receives substantially all of its funding from federal programs. The continuance of federal program funding is critical for the School to provide educational services.

TEEN DATING VIOLENCE AWARENESS MONTH

What is Dating Violence?

Dating violence is a pattern of abusive behaviors used to exert power and control over a dating partner.

A Pattern of Behavior

Calling dating violence a pattern doesn't mean the first instance of abuse is not dating violence. It just recognizes that dating violence usually involves a series of abusive behaviors over a course of time. Every relationships is different, but the one thing that is common to most abusive dating relationships is that the violence escalates over time and becomes more and more dangerous for the young victim.

Who Experiences Dating Violence?

Any teen or young adult can experience violence, abuse or unhealthy behaviors in their dating relationships. A relationship may be serious or casual, monogamous or not, short-term or long-term. Dating abuse does not discriminate – it does not see gender, sexual identity, economic status, ethnicity or religious preference.

What Does Dating Violence Look Like?

Teens and young adults experience the same types of abuse in relationships as adults. This can include: **Physical Abuse:** Any intentional use of physical force with the intent to cause fear or injury, like hitting, shoving, biting, strangling, kicking or using a weapon.

Verbal or Emotional Abuse: Non-physical behaviors such as threats, insults, constant monitoring, humiliation, intimidation, isolation or stalking.

Sexual Abuse: Any action that impacts a person's ability to control their sexual activity or the circumstances in which sexual activity occurs, including rape, coercion or restricting access to birth control.

Digital Abuse: Use of technologies and/or social media networking to intimidate, harass or threaten a current or ex-dating partner. This could include demanding passwords, checking cell phones, cyber bullying, sexting, excessive or threatening texts or stalking on Facebook or other social media. Ten Warning Signs of Abuse

While there are many warning signs of abuse, here are ten common abusive behaviors:

Checking your cell phone or email without permission

Constantly putting you down

Extreme jealousy or insecurity

Explosive temper

Isolating you from family or friends

Making false accusations

Mood swings

Physically hurting you in any way

Possessiveness

Telling you what to do

If you or a loved one is in a violent relationship, please get help.

Communities need to rise up and say **NO MORE**.

The Effect of Dating Violence

Less attention to academics. Increased exposure to drugs and alcohol. A greater likelihood of teen pregnancy. Growing isolation. Sexual assault. Even one of these things can have a profound impact on the physical, social and emotional growth of a young person. Together, they create a perfect storm that not only affects the victim of abuse, but their friends, families, schools and surrounding communities. And it goes beyond preventing the actual violence. Parents need to feel comfortable talking to their kids about these issues. Schools need to take steps to become better prepared to address incidents on campus.


