### LIVESTOCK SHOW ELIGIBILITY

To be eligible to show livestock at county and state fall fairs, an exhibitor must be enrolled in 4-H by July 1 prior to the fair.

To be eligible to show livestock at spring livestock shows, members must be enrolled by January 1 prior to the shows.

Jackpot shows and some others require members to be in 4-H 30 days prior to the show.
