MINUTES - NOVEMBER 19, 2015 - JOC MEETING

An executive session starting at 5:30 p.m. followed by a regular meeting of the Lawrence County Career and Technical Center Joint Operating Committee was held on **Thursday**, **November 19**, **2015** in the library at 750 Phelps Way, New Castle, PA at 6:30 p.m.

Leroy Cortez, Jennifer Grossman, Jeff Hammerschmidt and Mark Kirkwood were absent.

The meeting was opened with the Pledge of Allegiance and a moment of silence at 6:30 p.m.

1. PUBLIC COMMENTS

Rose Cook, Carl Perkins Instructional Aide, addressed the board members stating that she believes that the bargaining union did not bargain in good faith during the contract negotiations for the July 2015 – June 2018 contract. She stated that the aides are the lowest paid in the building and that Mary Jean Tuminella, co-op coordinator is paid by Carl Perkins funds. Mrs. Cook asked the board to renegotiate for the aides and draft a memorandum of understanding giving them the same raise that the secretaries and custodians received.

Debra Allebach thanked Mrs. Cook for her report and stated that noting would be discussed or decided at tonight's meeting.

was approved unanimously.

E. <u>ACCEPT THE JOINT PURCHASING AGREEMENT WITH THE</u> MIDWESTERN INTERMEDIATE UNIT IV ON A CONTINUOUS BASIS:

On a motion by James McFarland and seconded by Mark Panella, the Joint Purchasing Agreement with the Midwestern Intermediate Unit IV was approved unanimously. This agreement will be continuous and the LCCTC will give the MIU IV notice of termination.

F. APPROVE THE HIRING OF DUSTIN CHIARINI AS A SUBSTITUTE CUSTODIAN:

L. <u>ACCEPT THE RESIGNATION OF STEVE SHULIN, COLLISION REPAIR</u> INSTRUCTOR:

On a motion by James McFarland and seconded by Stephen Fornataro, the resignation of Steve Shulin, Collision Repair Instructor, effective November 13, 2015, was approved unanimously.

Mr. Rich, Director, sent out a thank you to Noga Ambulance EMT's for their presentation in the HA shop on first aid and their donation of supplies.

BC3 and CCAC are utilizing the career center for adult evening classes.

Mr. Rich also sent out congratulations to Keith Stitch for competing at an international competition in Las Vegas. He set a world record in the handicap division; Keith benched 292.11 pounds. Keith is alum of LCCTC and one of Mr. Rich's training partners.

Wednesday, November 25th, the LCCTC will host the annual LAC luncheon meeting from 11:00 a.m. – 1:00 p.m. Mr. Rich invited the JOC members to attend. December 3rd, the career center will host the annual OAC dinner meeting, starting at 6:00 p.m. All were invited to attend.

Mr. Joseph Mancini, Superintendent of Record, had no comments.
