- ✓ Type of Meeting (Regular, General, Executive, Special, Annual, etc)
- ✓ Name of Association
- ✓ Date, time and place of meeting
- ✓ List of persons in attendance and excused/unexcused absences
- ✓ Read an action on Minutes of previous meeting (Approved/Corrected)
- ✓ Treasurer's report (attach report to Minutes)
- ✓ Attach important reports i.e. Budget
- ✓ Record motions and if they were approved/rejected
- ✓ Time of adjournment
- ✓ Signature of Secretary



### PTA RESOURCES FOR FAMILIES ON EVERY STUDENT SUCCEEDS ACT (ESSA)



## Overview of ESSA - What every parent needs to know.

As you may have heard, in December 2015, the U.S. Congress passed the Every Student Succeeds Act (ESSA), a new law to replace the No Child Left Behind Act

(NCLB), and President Obama subsequently signed ESSA into law on December 10, 2015. However, you may not fully appreciate what this new act is and what you can expect from its implementation.

Under the ESSA, the challenge now turns to effective implementation of the law to ensure every child has the ability to reach their full potential. While this new law provides a great opportunity for states to tailor their education systems to meet the needs of their students—including students with disabilities—this new level of authority will also require an increased amount of responsibility for states to ensure they close achievement gaps.

### Impact of the ESSA on Tennessee

Tennessee's Department of Education has implemented a firm foundation for our students' future by raising standards to a more rigorous level that will prepare them for college and careers; establishing fully aligned assessments to ensure all of our students are developing problem-solving and critical thinking skills; and by using evaluation and accountability systems based on multiple factors. ESSA builds on this work by reaffirming the importance of standards, assessment, and accountability and through empowering states to make decisions for our kids. Although Tennessee is firmly on the right path, all states are required to fully transition to ESSA by the 2017-18 school year. The Department of Education gathered feedback from Tennessee's educators, key advocates, parents, students, and the public on specific policies. The feedback will inform a Tennessee-specific ESSA plan that will guide the department's work over the coming years and help the department capitalize on the new law's empowerment of local leadership.

### Parent and Family Engagement in ESSA

ESSA specifically calls for parents to be meaningfully involved and consulted in the development of state and school district education plans. These education plans provide the framework for how a state and school district will deliver education services to public elementary and secondary school students. Additionally, the law requires that parents must be involved in the creation of "state report cards" that provide information on how all schools in the state are performing—such as graduation rates, attendance and student achievement levels. The report cards must be written in a parent-friendly manner so that families can understand the

information provided and take action to support their child's education. What can you do to support family engagement at the local, state and federal levels?

### At the Local Level

- Join and volunteer with your local PTA to increase family engagement opportunities at your school.
- Volunteer to serve on your child's school improvement plan team.
- Visit the school district website to see how you can become involved in the district's parental involvement and family engagement initiatives.
- Reach out to school district leaders and engage with local education stakeholder groups to inform implementation of ESSA.
- Nominate yourself to serve on the committee that drafts the school district education plan required under ESSA.

### At the State Level

- Volunteer with your state PTA.
- Reach out to state education leaders and engage with state-level education groups to inform implementation of ESSA.



- Check your state's Department of Education website to see how you can be involved in the process for drafting the new state plan required under ESSA.
- Nominate yourself to serve on the committee that drafts the state's education plan and seek to include family engagement as an indicator of school success in the plan.
- Encourage your state to adopt the National PTA Standards for Family-School Partnerships and to prioritize family engagement in its state policy and guidance on school improvement.

### At the Federal Level

- Join the National PTA Takes Action Network and advocate on behalf of all children and families. Learn important advocacy skills and have access to resources that will help you become an even stronger advocate.
- Call on your Members of Congress to support family engagement by providing the necessary resources to support state and local activities.

## HIGH SCHOOLERS CAN APPLY NOW FOR FREE TUITION FOR COMMUNITY COLLEGE



Have a family member going to high school in the state? If so, did you know that the student could be eligible to attend a two-year community or technical college free of tuition?

<u>Tennessee Promise</u> is a scholarship and mentoring program that gives graduating high school students in the state the opportunity to attend a two-year community or technical

college without the need to pay tuition and mandatory fees. For high school students graduating in 2017, the application process is going on now. Students who are interested need to <u>apply</u> for the Tennessee Promise scholarship by Nov. I.

### How Tennessee Promise Works

High school graduates who complete the scholarship requirements receive two years of tuition-free education at any of the state's 13 community colleges, 27 colleges of applied technology or other <u>eligible institutions</u> that offer an associate degree program. All students are paired with a mentor who supports them during the college application process.

The program offers a "last-dollar" scholarship, which means it pays for tuition and fees not covered by the Pell Grant, the Tennessee Education Lottery Scholarship (TELS), including HOPE, or funds from the Tennessee Student Assistance Award (TSAA) program. Scholarship recipients must complete eight hours of community service with a nonprofit or public service organization before each term in which they are scheduled to receive funding for enrollment. For example, students graduating from high school in 2017 must complete and report their community service by July 1, 2017.

There is also support for adults to go back to school. <u>Tennessee Reconnect</u> is Governor Bill Haslam's initiative to help more of our state's adults enter higher education to gain new skills, advance in the workplace, and fulfill lifelong dreams of completing a degree or credential. Whether returning to finish a degree, going to college for the first time, or planning next steps as a veteran or service member, <u>Tennessee Reconnect</u> helps you explore those exciting possibilities.

## TENNESSEE PTA ARTS ENHANCEMENT GRANT For 2017-2018 School Year

**Deadline:** Applications are due in the state office on or before March 1, 2017.

### **Grant Overview:**

The Tennessee PTA Arts Enhancement Grant Program complements PTA's long-standing commitment to quality arts education by providing funds to local PTAs to establish or enhance arts programs in one or more arts areas: visual arts, photography, music (including dance) and literature (including theater). This grant is to be used for the National PTA Reflections program or the Tennessee PTA Citizenship Essay program.

Funding Available: Tennessee PTA expects to fund



4 grants up to \$250.00 each, with 3 grants to be awarded for use toward the National PTA Reflections program and I grant awarded to be used toward the Tennessee PTA Citizenship Essay

program.

What Tennessee PTA will Fund: Tennessee PTA is placing a priority on funding projects that represent research based best practices in arts education. Specifically PTA will fund art programs that:

- Are of a sustained nature (rather than one time event)
- Reach large numbers of at-risk students.

Extensive research indicates that students receive the greatest benefit from programs that include sustained involvement in the arts. Therefore, Tennessee PTA is funding proposals for sustained programs that culminate in a performance, an art fair, an assembly, or a field trip, rather than those that request funding for one day or one-time events. Ideally the activities will take place through-out the school year and will involve families, students, schools and/or communities.

At risk encompasses a wide range of factors that may make it more difficult for a student or a segment of the student population to succeed in learning. Some factors that make students at risk are financial, health, behavioral, social, and environmental or other community conditions. Local PTAs must submit the complete application and match this grant dollar for dollar with PTA or other donated funds and/or in-kind resources.

Project timeline: Proposed program activities may take place from close of convention 2017 through March I, 2018. Grant reports are due thirty days after the end of the grant project or on March I, 2018, whichever comes first.

### **Eligibility:**

The applicant must be a PTA in good standing with the following items in compliance:

- Proof of 990 filed with the IRS
- Audit report filed with Tennessee PTA
- Membership report and dues paid by December I
- Current bylaws approved by Tennessee PTA.

Criteria for Selection: Applications must be complete and submitted on time. Incomplete or late applications will artsnot be reviewed.

## Applications will be scored based on the following criteria:

Program Description – 45 points

General description, geographic area, new or innovative approaches, inclusion of research based best practices, partnerships, family engagement, and student success Goals and Outcomes – 25 points

What are the goals of the program? What are the anticipated outcomes? How will success be determined? At-Risk – 10 Points

To what extent are at-risk students served through the proposed project? Need – 10 Points

What is the need for this project? Budget and Budget Narrative – 10 Points

Total Score Possible – 100 Points

## MY PTA STORY - - -

I was an elementary homeroom mom, and a good friend, Donna Aslinger and Mildred Shipley, encouraged me to do Middle School PTA. I was that parent that believed PTA stopped in Elemen-



tary. I served in every position Sale Creek School Middle/High PTSA offered. I then was invited to join the council and was asked several times to consider being a region director. I never felt I could do this position and then one day I decided to try and LOVE being in schools and being the Southeast Region Director.

My story goes back to 1991 when my daughter Julie was in kindergarten. I attended my first PTA meeting as a parent and almost never went back because it turned out to be a MOM's Club. Elections were coming up and none of the moms wanted to be president, so they nominated and elected me - change in PTA began. I got dads involved, shortened the meetings and ran business by Robert's Rules of Order. In time, made a successful school merger transition and was elected to the state board in MI serving several years before moving to TN and serving on the state board now. "Children First" is what got me into PTA."

In 1997. I attend my first school Open House. The PTA leader invited everyone even family not in town to join PTA. I joined PTA with a zeal, became a local unit legislative chair and school board monitor. Advocacy caught my attention ever since.

I am active in PTA because of my granddaughters. They are 10 and 6 years old. I wanted to be an active part of their education. Now, I serve as a council leader and on the state board simply because I was **ASKED**.

## TREASURERS' TIP Reminder – November 15 DUE DATE!!!

### FEDERAL TAX REQUIREMENTS

### (Note: Refer to www.IRS.gov for the latest updated requirements and information)

All local units are subject to the reporting requirements of the Internal Revenue Service. The specific form required to be filed by any local unit is determined by the level of its finances. The following detailed information for each form is provided to give you an idea of which reporting requirement is appropriate for your unit. Additional information concerning federal requirements can also be found in National PTAs *"Money Matters Quick Reference Guide"*.

## Information Return of Organization Exempt from Income Tax—IRS Forms 990 and 990-EZ:

Local or council PTAs may be required to file an annual information return of their income and expenses on Form 990 (Information Return of Organization Exempt from Income Tax) and other related information forms provided by the IRS, such as Schedule A and Form 990-T. The IRS normally sends such forms to tax-exempt associations, but the responsibility of filing lies with the PTA Treasurer, whether or not such forms are received.

- If a PTA receives a Form 990 package in the mail, with an addressed mailing label, but is not required to file because its annual gross income is normally not more than **\$50,000**, the Treasurer should proceed as follows:
  - Attach the label in the name and address space on the Form 990.
  - Check box K (in the area above Part 1) to indicate that the PTA's gross receipts are below the \$50,000 filing minimum.
  - Sign the return.
  - Keep a copy for the PTA's permanent records and send the original to the area IRS service center by registered mail.
  - The Treasurer does not have to complete Parts I through IX.
- If the PTA's annual gross receipts are normally more than \$50,000, the PTA has an obligation to complete and file Form 990 and Schedule A, whether or not it received them in the mail.
- If in any year the PTA's gross receipts are less than \$200,000 and total assets are less than \$500,000, the Treasurer may file Form 990-EZ instead of Form 990.
- Forms 990 and 990-EZ are due by the 15th day of the fifth month after the close of the PTA's fiscal year. For example, if the PTA's fiscal year-end is June 30, the form is due November 15.
- If the return is filed late, a penalty of \$20 a day may be charged. The penalty is not to exceed the lesser of \$10,000 or 5 percent of the association's gross receipts for the year. Also, a penalty may be charged if the return is filed incorrectly or incompletely.

## **TREASURERS' TIP** Reminder – November 15 DUE DATE!!!

- If the PTA is required to submit a completed Form 990 or 990-EZ, it must submit a Schedule A as well (501(c)(3) organizations are not required to file Schedule A, but must file a Form 990 or 990-EZ as required).
- If the PTA makes more than \$1,000 in unrelated business income, it must file a Form 990-T as well.
- If the PTA has made significant changes to its bylaws (i.e., change in fiscal year, change in governance/structure), a copy of the updated bylaws should be submitted to the IRS with the completed Form 990 or 990-EZ.
- If the PTA wishes to request an extension of time to file Form 990 or 990-EZ, it should complete and file Form 8868 with the IRS before the deadline determined by the close of the PTA's fiscal year.

### Form 990-N Annual Electronic Filing Requirement (e-Postcard):

A small tax-exempt organization whose gross receipts are normally **\$50,000 or less** is required to electronically submit Form 990-N, also known as the e-Postcard. The e-Postcard is due every year by the 15th day of the 5th month following the close of your association's tax year.

### Items You Need to Know to File the e-Postcard:

- Employer identification number (EIN)—also known as TIN
- Tax year
- Association's legal name (Tennessee Congress of Parents and Teachers Inc. ,since your PTA uses Tennessee PTA's 501(c)(3) status).
- Any other names the association uses and mailing address (This will be the official name of your PTA)
- Name and address of a principal officer
- Website address of the association (if there is one)
- Confirmation that the association's annual gross receipts are normally \$50,000 or less
- If applicable, a statement confirming that the association has dissolved or is dissolving

The IRS will revoke your PTA's tax-exempt status if you fail to file the required tax forms for three consecutive years.


NOTE: Any parent group that no longer retains its affiliation with the National and State PTAs must file form 1120 and pay income tax on all receipts unless they apply for and receive tax-exempt status. Tennessee PTA is obligated to notify IRS when a group is no longer considered a PTA.


