New Program at Chattanooga State Technology School

Tool and Die Maintenance Technician - With the resurgence of manufacturing in the Chattanooga region, the demand for skilled technicians is increasing. The Tool and Die Maintenance Technician program is dedicated to meeting the needs of manufacturers in need of tool and die maintenance technicians to repair tools and dies, maintain and operate press machines, create basic die sets, and operate machines that are used in making die sets. The graduate from this multi-craft program will have excellent employment opportunities with salaries in the range of \$23-28/hour.

Classes will be taught on the Chattanooga State main campus. This program is three semesters in length (1290 clock hours) and it is designed for completers of either a machine tool or industrial maintenance Tennessee College of Applied Technology (TCAT) program. Persons with five years of experience in machining or plant maintenance operations may substitute this experience for the program completion requirement for acceptance into the program. Upon successful completion of the tool and die program, graduates will receive a TCAT Technical Diploma from Chattanooga State.

November 1, students will be eligible to pay their non-refundable enrollment deposit online for UTK. Housing will start sending contracts out mid-November to students that have confirmed. Orientation registration will be available mid-January.

<u>Better Business Bureau Scholarship</u> – NOT INCOME BASED - Based on Community Service (20%), Academics(10%), extra-curricular activities(20%) and essay(50%); 500 word essay on "The importance of ethics in business and our community" \$1000 – Deadline to give to Career and College Counselor – April 2nd – See scholarship file for applications – BBB - <u>This scholarship is NOT associated to income!</u>

<u>BLOOD ASSURANCE</u> –Not income based – Design a catchy slogan for the blood drives – Due to College and Career Counselor by March 26th – Must have a 3.0 GPA and 20 ACT – in scholarship file http://www.bloodassurance.org/downloads/ScholarshipApplication.pdf

<u>UTC YES SCHOLARSHIP</u>- \$3000 per year –Must submit UTC application and complete the UTC scholarship application. You must also fill out the FAFSA and UTC financial aid forms after Jan 1st but before April 1st Everything must be in by April 1 –Based on income –low income students with a 3.0 GPA and 19 ACT will be given additional consideration

<u>UTC SCHOLARSHIPS -</u> These are on a first come basis. To complete – LOG INTO MOCSNET ACCOUNT USING THE INFORMATION ON YOUR ACCEPTANCE LETTER. Click on the money tab. In the bottom right hand corner click on freshmen scholarships. FILL OUT THE SCHOLARSHIP APPLICATION COMPLETELY - This means if your ACT is below a 24 and your GPA below a 3.4 you will write the essay and get teacher recommendations. If you do not, you will not get a scholarship. If you submitted before doing this, call UTC and ask them to reset your scholarship application so you can enter again. AGAIN – FILL IT OUT BEFORE CHRISTMAS OR ASAP after receiving your acceptance letter.

UTC Grote Chemistry Scholarship - must be accepted to UTC, majoring in Chemistry (including pre-med or pre-dental) and have a high school GPA of 3.5, completed a high school chemistry class with an A or a B, and 26 ACT or 1170 SAT - \$3500 renewable for 4 years - Deadline is Feb 15- http://www.utc.edu/Chemistry or http://www.utc.edu/Academic/Chemistry/Students/scholarship/Grote/GroteInfo.php
