Dear Parent/Guardian,

Hunter Middle School utilizes the Olweus Bullying Prevention Program (OBPP) to prevent bullying behavior. OBPP is a program that deals with bullying behavior at the school-wide, classroom, and individual level. Here is what happens at HMS at each level:

School-wide:

- Teachers/staff are trained to use the program to deal with bullying behavior
- Students will complete an anonymous questionnaire in October and May to give HMS administration information about the amount and type of bullying behaviors occurring at our school
- All students will follow the four anti-bullying rules (see below)
- Anti-bullying messages and how to report bullying behavior will be delivered on WHMS News
- BINT (Bullying Is Not Tolerated) forms are available for reporting bullying behaviors

In the classroom:

- The four anti-bullying rules and the Bullying Behavior Rubric are reviewed in the classroom
- Class meetings are held every two weeks from October through May to help students understand what bullying is, why it should not occur, and how to prevent or report bullying behavior
- 6th grade students get additional training in cyber bullying prevention
- The I-Safe Program is taught through the physical education department

Individual:

- Consequences assigned according to the Bullying Behavior Rubric (on back of this letter)
- An individualized Bullying/Harassment/Intimidation Action Plan is created

Although the program takes place at school, we need your help too. Please talk to your child about bullying, review the anti-bullying rules and Bullying Behavior Rubric, and report suspected bullying behaviors to school administration with the BINT Form (obtained from school or HMS's website).
