COURSE DESCRIPTIONS

Information Technology Foundations (ITF) is a course intended to provide students with exposure to various information technology occupations and pathways such as Networking Systems, Programming and Software Development, and Web Design. As a result, students will complete all core standards, as well as standards in two of three focus areas. Upon completion of this course, proficient students will be able to describe various information technology (IT) occupations and professional organizations. Moreover, they will be able to demonstrate logical thought processes and discuss the social, legal, and ethical issues encountered in the IT profession. Depending on the focus area, proficient students will also demonstrate an understanding of electronics and basic digital theory; project management and teamwork; client relations; causes and prevention of Internet security breaches; and writing styles appropriate for web publication. Upon completion of the ITF course, students will be prepared to make an informed decision about which Information Technology program of study to pursue. Standards in this course are aligned with Tennessee State Standards for English Language Arts & Literacy in Technical Subjects and Tennessee State Standards in Mathematics

TEXTBOOK

A variety of textbooks and supplementary materials will be utilized in this course.

COURSE REQUIREMENTS

Attendance: Each student will be expected to be in class for all regularly scheduled meetings. A student's schedule is considered a contract and constitutes a series of obligated appointments. Absences are counted from the first scheduled meeting of the class. Roll is taken at the beginning of each class meeting. Each student should be at his/her assigned seat or workstation ready to begin working when the bell rings.

The Hamilton County Department of Education believes that attendance is a key factor in student achievement. Students are expected to be present and punctual each day that school is in session.

Absences: Students are expected to be in school and on time for each class. A student who is not in school for at least half the day will be counted absent for the day.

Tardiness

Late arrival disrupts class and causes loss of instruction time. Any student who arrives at school after 7:25 a.m. must obtain a pass to give to his/her first period teacher.

Tardy Policy:

1-3 tardies per class = warning

4-6 tardies per class = detentions

7-9 tardies per class = ISS

10th tardy = suspension and parent meeting with social worker.

Course Credit: A minimum 142 scheduled of hours are required for a student to receive one credit in a course. The student must be productive (on-task, following course objectives, and completing assignments) in order to receive credit for hours spent in class.

Daily Assignments and Participation: Daily practice assignments completed both in and outside of class as homework will be collected and reviewed for completeness including accuracy and the ability to complete the task following all directions. All assignments must be completed in order to receive any credit (no partial credit).

Behavior Policy:

The following classroom behavior will be observed by all students:

- Be on time and prepared for class.
- No food or drink in the classroom, except water.
- To use the Internet, permission will be obtained. You must be in compliance with the Hamilton County Schools Acceptable Use Policy.
- Always be respectful to classmates, teacher, and computers.
- All Signal Mountain Middle High School rules apply to conduct in the classroom (see student handbook).

Technology User Agreement and Guidelines: Please read and sign the attached computer usage agreement and return it to the instructor before being able to use the computer.

Projects Individual/Group: Projects will be done throughout the year. Some projects will require presentations and some will not. Projects are a key part of this class.

Essential Question: Essential Questions will be written in a notebook or journal at the beginning of every class period. Every question will be answered at the end of class. All essential questions will be turned in for a test grade at the end of the semester.

Make-Up or Late Work: All assignments are due at the beginning of class on the assigned due date. Per HCBE make-up policy you have 5 days to make-up work after being absent.

Exams and or projects: Most test grades from I.T. Foundations will come from project; however some will be a combination of multiple choice and true false.

Final Exam: A comprehensive final exam will be given at the end of each semester. The exam will be multiple choice and true false.
