MEMORANDUM FOR Distribution

SUBJECT: Trojan Battalion Rafting Trip

- 1. Trojan Battalion Cadets and Parents, this year we will be conducting an adventure training day on April 16th, 2016. First, we will be going to Outland Expeditions (OE) to whitewater raft down the Ocoee River. After completing the trip down the Ocoee, our buses will take us to Outdoor Adventure Rafting (OAR) to eat and use the adventure obstacles available. Some of the obstacles and activities include; high ropes course, rock wall climbing, paintball, and other adventure training activities.
- 2. On the 16th of April, all participants and support personnel must be at the school No Later Than (NLT) 5:45 AM with the items listed in paragraph three (3). An accountability formation will take place in parking lot E (adjacent to the facility parking lot and near the old tower) at that time. Cadets and Chaperones will be organized in buddy teams and chalks that represent boat team assignments. The buses will depart at 6:20 AM for OE. On arrival at OE, chalks will reform and await direction from the OE Rafting Guides. After returning to OE from rafting, cadets will change into dry clothes. All participants will remain in assigned chalks for the duration of the rafting portion of the trip. At approximately 1:00PM chalks will load buses for OAR. The Support team will meet the participants at OAR and provide directions for lunch. After the meal, Cadets will form into their buddy teams for the afternoon activities and await instructions from OAR guides. A snack will be served at approximately 4:30 PM. Activities will conclude NLT 6:30 PM with a 7:00 PM departure time from OAR. Buses are scheduled to arrival back at the school at 8:30 PM. Participants will be dismissed upon arrival at the school after a brief accountability formation.
- 3. Cadets Who will be attending the trip need to bring the following clothing and equipment. Swimming trunks, (Males- Swim Trunks, Females- one piece suit) non see-through t-shirt, water shoes/old pair of athletic shoes, a towel, a water bottle, sunscreen and any necessary allergy or asthma equipment. (Optional items:bug spray) Cadets will arrive dressed in there swimming clothing and need to bring a carry on bag containing a water bottle, and PT uniform (athletic shorts, t-shirt, a dry pair of undergarments, socks, and ATHLETIC SHOES.) Again, Lunch and a snack will be provided for the Cadets on the trip. This packet contains the necessary waivers and forms for your child to attend this trip. The fee for this trip will be \$30 per Cadet if they participated in the Battalion fundraiser. If they did not participate, the charge will be \$38. Please make out all checks to Soddy Daisy High School.
