(A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to my child or to me including my traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: Jefferson Middle School, its administrator or employees and/or its directors, officers, employees, volunteers, representatives, and agents, the activity or event holders, activity or event sponsors, activity or event volunteers, as well as the Jefferson County Board of Education, its members and employees.

(B) I INDEMNIFY, HOLD HARMLESS, AND HOLD NOT LEGALLY RESPONSIBLE the entities or persons mentioned in the above paragraph from any and all liabilities or claims made as a result of participation in this activity or event, whether caused by the negligence of release or otherwise.

I acknowledge that Jefferson Middle School, its administrator or employees and their directors, officers, volunteers, representatives, and agents including the Jefferson County Board of Education, its members and employees are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of said school.

I acknowledge that this activity or event may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather condition or participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event, and lack of hydration, These risks are not only inherent to participants, but are also present for volunteers.

I hereby consent for my child or me to receive medical treatment which may be deemed advisable in the event of injury, accident and/or illness during this activity or event.

I understand that at this event or related activities I and/or my child may be photographed. I agree to allow the photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and assigns. The accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
