

## Glen Rose Intermediate School Bus Referral Procedures

All students at Glen Rose Intermediate School have the opportunity to utilize the GRISD School Bus System. However, bus referrals may be written on a child anytime the bus driver feels that the safety and security of the other students might be in danger. Below you will find the procedure Glen Rose Intermediate School will use in dealing with bus referrals. **RIDING A BUS TO SCHOOL IS A PRIVILEGE PROVIDED BY GRISD.**

### Level 1

Offense	Disciplinary Consequences
I-1 Refuse to follow bus rules	1st Referral-Campus consequence
I-2 Possessing and/or using nuisance items	2 <sup>nd</sup> Referral-Campus consequence & Parent contact
I-3 Disruptive behavior	3 <sup>rd</sup> Referral-Loss of one(1) day after school bus riding privilege & Parent contact
I-4 Failure to remain seated	4 <sup>th</sup> Referral- Loss of two(2) days after school bus riding privileges & Parent contact
I-5 Public display of affection/inappropriate engaging in acts with other students	5 <sup>th</sup> Referral- Loss of three(3) days after school bus riding privileges & Parent contact
I-6 Excessive mischief	6 <sup>th</sup> Referral-Move to Level II Consequence
I-7 Unnecessary noise	
I-8 Hanging out of window	
I-9 Violation of safety procedures	
I-10 Encouraging & contributing to conflict between students	

### Level 2

Offense	Disciplinary Consequences
II-1 Student's behavior does not change as a result of level I	1st Referral- Loss of three(3) days after school bus riding privileges & Parent contact
II-2 Failure to comply with lawful directives issued by school personnel	2 <sup>nd</sup> Referral- Loss of three(3) days bus riding privileges (before & after school) & Parent contact
II-3 Throwing or irresponsible use of objects that can cause bodily injury or damage to property	3 <sup>rd</sup> Referral- Loss of four(4) days bus riding privileges (before & after school) & Parent contact
II-4 Exhibiting unacceptable or unwanted physical contact that could, but does not, result in injury	4 <sup>th</sup> Referral- Loss of five(5) days bus riding privileges (before & after school) & Parent contact
II-5 Hazing	5 <sup>th</sup> Referral-Move to Level III Consequences
II-6 Minor vandalism to or defacing school property	
II-7 Using profane, obscene, indecent, or racially/ethically offensive language &/or physical gestures toward students	
II-8 Confronting or posturing to fight another student	

### Level 3

Offense	Disciplinary Consequences
III-1 Student's behavior does not change as a result of level II	Handled according to <u>Discipline Management Plan</u> and Loss of five(5) or more days bus riding privileges (before & after school) & Parent contact
III-2 Fighting or mutual combat	
III-3 Disrespectful of school personnel or refusing to comply with lawful requests/directions of school personnel	
III-4 Using profane, obscene, indecent, or racially/ethically offensive language &/or physical gestures toward school personnel or in public settings	
III-5 Possession or use of tobacco products, cigarette lighters or matches on campus or at any school related activity
