

**Bamberg School District One**  
**Minutes of Regular Meeting of Board of Trustees**  
**Bamberg-Ehrhardt Middle School**  
**November 21, 2016**  
**6:30 p.m.**

1. **Call meeting to order:** Vice Chair Chris Wallace called the meeting to order and asked for a moment of silence.

3. **Approval of Agenda**  
**Trustee Janeth Walker moved and Trustee John Hiers seconded to approve the agenda as presented.** The motion passed 4-0.
4. **Approval of Minutes**  
**Trustee Tony Duncan moved and Trustee Janeth Walker seconded to accept the October 17, 2016 and November 17, 2017, minutes as presented.** The motion passed 4-0.
5. **School Reports: Stacey Walter, Sandra B. Glover, and Randall L. Maxwell**

6. **Student/Staff Recognition and Superintendent's Report**  
Superintendent Schwarting reported the following:
  - Congratulations were extended to Trustee Janeth Walker for having reached Level Two in the Boardmanship Institute Training Program through South Carolina School Boards Association during the Fiscal Year 2015-16. She received a certificate of achievement and a pin. Due to the absence of Board Chair Kedra Rivers, she will be given a certificate and a pin for reaching Level Four training at the next meeting.
  - Student School Enrollment as of November 1, 2016: Richard Carroll Elementary – 760; Bamberg-Ehrhardt Middle School – 219; and Bamberg-Ehrhardt High School – 423. Total enrollment – 1,402. [Board Packet Hand-out]

- Upon the request of Superintendent Schwarting, **Trustee Janeth Walker moved and Trustee John Hiers seconded for Candidate A to receive a Bamberg-Ehrhardt High School Diploma through Act 155.** The motion passed 4-0.
- The District scored overall well and in some areas above the state on the SC Ready Test, the ACT test, and the ACT WorkKeys test. The SAT scores increased from last school year, and the End of Course test scores were higher than the state in all areas with the exception of Biology I. [Handout]
- The administration received \$273,915 worth of services in E-Rate which cost the District a little over \$20,000 (Matching Funds).

7. **Date for December Meeting**

Following a discussion on the rescheduling of the December 19, 2016, Board meeting due to the closing of school on December 16<sup>th</sup>, **Trustee Janeth Walker moved and Trustee Tony Duncan seconded to table the matter (December 2016, Board Meeting) and make a decision by December 9<sup>th</sup>.** The motion passed 4-0.

8. **Board Salaries/Compensation**

**Handouts:** Bill 4170 – SC General Assembly

Policy BID – Board Member Compensation and Expenses

Superintendent Schwarting noted that in order to change the salary for Board members, a legislative process must be followed. Nevertheless, the money amount does not have to be approved by legislators.

**Trustee Tony Duncan moved and Trustee Janeth Walker seconded to table “Board Salaries/Compensation” until January 2017, in order for more information to be obtained.** The motion passed 4-0.

9. **2016-2017 School Calendar - Revised**

Due to the closing of school for Hurricane Matthew (6 days), Superintendent Schwarting requested that the District’s 2016-2017 School Calendar be revised to accommodate three days that the Governor has not approved (Days 1, 2, and 3). All changes will be during the second semester – staff development days moved to student days. The administration does not anticipate any problems with students who attend the Cope Career Center at this time. The closing of school will remain June 2, 2017.

**Trustee John Hiers moved and Trustee Tony Duncan seconded to accept the revised 2016-2017 School Calendar as presented by Superintendent Schwarting.** The motion passed 4-0. [Board Packet Enclosure]

10. **Monthly Financial Report**

Finance Director Devon Furr presented the Financial Report as of October 31, 2016.

Mrs. Furr noted that the administration has applied for a Carolina Panthers Grant (Approximately \$20,000) through the Hurricane Matthew Relief Aid that will help in reconstructing the wall at the baseball field. Hopefully, with the insurance coverage and money from the grant the wall can be replaced. In order for the wall to be re-constructed, the rules of the Office of School Facilities must be followed (Structural Engineered Plan). Insurance money will come, however, it may not be enough to cover all the damages.

Superintendent Schwarting noted that Bamberg County EMT Coordinator may be able to get the district some money through some other programs. Money to repair the ceiling tiles in all the schools will come from the district's insurance company. The insurance deductible is \$5,000. [Board Packet Enclosure]

11. **Visitors' Comments**

No comments were given from the visitors.

12. **Executive Session**

Vice Chair Wallace called for a **motion to enter Executive Session**. Trustee Tony Duncan **moved and Trustee John Hiers seconded to enter Executive Session**. The motion carried 4-0.

**Open session:** Trustee John Hiers **moved and Trustee Janeth Walker seconded for the Board to come out of Executive Session and return to the regular session of the meeting**. The motion passed 4-0.

**Superintendent's Evaluation and Personnel Recommendation for Termination**

**Trustee Janeth Walker moved and Trustee Tony Duncan seconded noting that there was no action taken in regards to the *Superintendent's Evaluation* and to accept the recommendation (termination) of the Superintendent regarding employee A**. The motion passed 4-0.

**Trustee Tony Duncan moved and Trustee John Hiers seconded to adjourn the meeting**. The motion passed 4-0.
