PERMIT TO DRIVE

This form must be signed and returned to the office. Mr. Pruitt changed the policy. If you have a parking permit and have it registered with the office, you will not have to buy another one. If you lost it, you will have to. You still need to fill out the form with all vehicles you might drive to school If not a driver yet, please indicate that. Thank you.

STUDENT DRIVERS

Student drivers of licensed vehicles must have a valid driver's license, insurance and registration. Student drivers are to be courteous and show proper conduct while in their vehicles. All vehicles driven to school by students are to be registered in the principal's office. Upon proper registration and payment of designated fee, a parking permit will be issued. <u>PARKING PERMITS</u> <u>MUST BE DISPLAYED AT ALL TIMES WHILE ON SCHOOL PROPERTY</u>. Failure to comply may result in student losing driving privileges. <u>FAILURE TO PURCHASE A PARKING PERMIT WILL RESULT IN CARS</u> <u>BEING TOWED</u>.

- 1. Upon arrival at school, vehicle will be parked in the fenced student parking lot which is west of the band room and north of the road. It will not be moved until the student is released from classes for the day or has permission from the principal to leave campus. Student drivers are not to pick up riders and leave campus without permission. Vo-tech students eating in the cafeteria are to walk; vehicles are not to be moved until leaving campus for Vo-tech.
- The speed limit in the school zone is 20 mph. This speed zone will be observed at all times during school hours or when students may be arriving at or leaving to school. (<u>THE SPEED ZONE BEGINS AT A POINT ¹/₄</u>)
 <u>MILE NORTH, SOUTH, EAST AND WEST OF THE SCHOOL.</u>) Speed limit in the school parking areas is 10 mph.
- Students <u>will not</u> be in their vehicles except upon arrival and departure from school. Students <u>will</u> <u>not</u> be allowed to sit in vehicles across from the school or on school property before, during or after school hours.
- 4. Cost of permit is \$5.00. If not lost or destroyed, permit does not have to be renewed.
- 5. Failure to abide by these rules WILL result in driving privileges being revoked.

VEHICLE ALARMS

All student vehicles which are equipped with alarms must indicate the type of alarm on this student vehicle registration form. The only types of alarms that will be allowed to be activated while on campus are glass sensor and door pins. <u>Motion sensor and</u> **motion detector type alarms will not be allowed to be activated while on campus.**

CAR STEREOS

Students should not play car stereos at maximum volume or at a volume which is loud and disruptive. Stereos are to be heard inside vehicles only. Students who violate this policy will be prohibited from playing their car stereos on school grounds.
