It is our hope that this additional data will be helpful. We certainly want to do all we can to keep you informed and to encourage all parents and patrons to become actively involved in the education of the students we serve. The most valuable resource of a strong, vibrant community is the children of that community. As we work together to provide our students with quality educational opportunities each and every day, we are all doing our part in helping all children realize their dreams.

#### BOONE CENTRAL MISSION STATEMENT

The Boone Central School District is in year one of a new School Improvement Cycle. Below is the mission statement for the consolidated School district, which was written and approved by the steering committee and was adopted by the School Board at the March 2003 meeting.

The **MISSION OF BOONE CENTRAL SCHOOL**, together with family and community, is to prepare all students for a life of learning.

- \*\* Students need to develop social responsibility.
- \*\* Students need to share responsibility for their learning.
- \*\* Students need to be challenged to develop to their full potential.
- \*\* Students need a positive learning environment, which encourages aesthetic, physical, and emotional development.
- \*\* Students need to develop respect for all people and for the environment.

When beliefs become practice, only then will the mission of the Boone Central Schools become a reality.

#### THE BOONE CENTRAL SCHOOL DISTRICT #06-0001

The Boone Central Schools are comprised of Boone Central High School (9-12 in Albion), Boone Central Middle School (6-8 in Petersburg) Boone Central Elementary School (K-5 in Albion), and ABC Preschool (PK in Albion). Boone Central High School is classified by the Nebraska State Activities Association as a Class C-1 School. Boone Central Schools is accredited by AdvancEd of Nebraska and is in good standing.

A major factor in the quality of life of the people living in the communities of Albion and Petersburg is the quality of the public school system. ABC Preschool was an excellent educational addition to the school system during the 2006-07 School year. Another important educational addition has been Pathways Alternative School started in the fall of 2007 in cooperation with surrounding school districts. Unique to the Boone Central School has been the ability of teachers to integrate units of instruction into an existing broad curriculum for our 80-acre Olson Nature Preserve and our community business partners such as the Albion and Petersburg banks, the Good Samaritan Wolf Memorial Home, and the Boone County Historical Society. Starting with the 2013-14 school year, Career Academies have been added at the High School. A partnership between Boone Central Schools and local businesses allow for students to work towards a career while still in high school. The partnerships will allow for our students to experience careers in the local area while still attending high school. Place-based instruction

coordinated to state standards in the Boone Central School strengthens the school connection to the families, farms, and businesses that support the school. The variety and depth of Boone Central class offerings and special education opportunities give evidence that a rigorous and comprehensive curriculum is at the heart of the School system.

The community of Petersburg had a wind farm made up of 54 turbines completed during the first half of the 2010-11 school year. Work has been completed on a second phase of wind towers east of Petersburg. There are now a total of 81 towers east of Petersburg. Boone Central is working on offering students classes in renewable energy through our Career Academies. This career field has grown a great deal in the past few years and Boone Central would like to be a front-runner in this area. There are now a number of careers associated with renewable energy.

Boone Central Schools were created when the Albion and Petersburg schools combined for the benefit of the students in those districts. With the large array of classes we are able to offer, the students of Boone Central are well prepared for the 21<sup>st</sup> Century, as evidenced by the fact that we have a large number of students attending post secondary education institutions.

BCHS is a member of the Mid-State Conference and we are very proud of its academic and activity tradition. BCHS has earned numerous State Championships and runner-up finishes in a variety of athletic and academic oriented programs. The support of patrons, businesses, and our Booster Club has allowed BCHS to provide many opportunities to our students involved in the activities program. We have a large number of students involved in organizations such as SADD, National Honor Society, FCCLA, FBLA, and Student Council that work in the area of community involvement. These groups are involved in securing donations for the local food pantry, providing mentors for elementary students, and hosting a Post-Prom and Post-Color Day activity for students.

During the 2011-12 school year, Boone Central began a sports co-op with Newman Grove Public Schools. This co-op started in middle school and has included high school athletics beginning with the 2012-13 school year. The coop has been a welcome addition to our students, coaches and parents at Boone Central.

#### **BUDGET INFORMATION**

The Boone Central School general fund request for 2013-14 is \$8,802,245. The budget includes a \$7,246,453 property tax requirement. The levy to fund this property tax is 0.6467 dollars per \$100 of assessed valuation. The owner of property assessed at \$50,000.00 would pay \$323.35 in taxes for the operation of the general fund of Boone Central School.

In addition the district has a special building fund and a bond fund. The special building fund pays for the major renovations the district has completed over the years. The special building fund levy is 0.1399 cents per \$100 of assessed valuation. The district no longer has debt on any bonds paid through the years.

The primary source of revenue for the School district is local property taxes with a small amount of state aid as well. The district also receives revenue from the federal government, the county, and other local miscellaneous sources.



#### **Child Find**

Child Find is a service to assist children with disabilities and their families. It is a law in Nebraska that educational services must be provided for children with disabilities, from birth or date of diagnosis through the School year in which the student becomes 21 years of age. If you know a child who is not currently being served, please call the Boone Central School Superintendent's office at (402) 395-2134.

#### Family Educational Rights and Privacy Act (FERPA)

The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a Federal law that protects the privacy of student education records. The law applies to all School that receive funds under an applicable program of the U.S. Department of Education.

FERPA gives parents certain rights with respect to their children's education records. These rights transfer to the student when he or she reaches the age of 18 or attends a School beyond the high School level. Students to whom the rights have transferred are "eligible students."

- Parents or eligible students have the right to inspect and review the student's education records maintained by the School. School is not required to provide copies of records unless, for reasons such as great distance, it is impossible for parents or eligible students to review the records. School may charge a fee for copies.
- Parents or eligible students have the right to request that School correct records, which they believe to be inaccurate or misleading. If the School decides not to amend the record, the parent or eligible student then has the right to a formal hearing. After the hearing, if the School still decides not to amend the record, the parent or eligible student has the right to place a statement with the record setting forth his or her view about the contested information.
- 3 Generally, School must have written permission from the parent or eligible student in order to release any information from a student's education record. However, FERPA allows School to disclose those records, without consent, to the following parties or under the following conditions (34 CFR § 99.31):
  - School officials with legitimate educational interest;
  - Other School to which a student is transferring;
  - Specified officials for audit or evaluation purposes;
  - Appropriate parties in connection with financial aid to a student;
  - Organizations conducting certain studies for or on behalf of the School;
  - Accrediting organizations;
  - To comply with a judicial order or lawfully issued subpoena;
  - Appropriate officials in cases of health and safety emergencies; and
  - State and local authorities, within a juvenile justice system, pursuant to specific State law.

School may disclose, without consent, "directory" information such as a student's name, address, telephone number, date and place of birth, honors and awards, and dates of attendance. However, School must tell parents and eligible students about directory information and allow parents and eligible students a reasonable amount of time to request that the School not disclose directory information about them. School must notify parents and eligible students annually of their rights under FERPA. The actual means of notification (special letter, inclusion in a PTA bulletin, student handbook, or newspaper article) is left to the discretion of each School.
