Dear Brigantine School Community,

As you are aware from earlier correspondence, our school system conducted testing of the school district's water for lead to protect our community and be in compliance with the Department of Education regulations. The results of these tests were sent home and are also available on the District's website.

As a follow-up to those initial results, we completed a second round of required testing on those water outlets that were initially identified as higher than the 15 µg/l (parts per billion [ppb]) recommendation level provided by the NJ DOE and NJ DEP regulations. In the second round, non-flushed and flushed samples were taken. The first sample was taken once the source was "turned on" (Non-Flushed) and a second sample was taken after allowing the water to run for thirty seconds (Flushed). The results of these tests are detailed below.

Brigantine Elementary School

Thirty-six samples were taken at eighteen locations – the first was non-flushed and the second was flushed. All but four of the results tested below the 15ppb benchmark. This indicates that the elevated reading is coming from the immediate area of the faucet/outlet – lead was often used in plumbing materials until it was banned in 1986. Those outlets can and will be replaced. The water will remain shut off to these locations until the faucets are replaced and testing is completed to confirm the correction of the issue.

The four that tested with the elevated levels remain shut off as well. Those locations are listed below and signage is posted stating "DO NOT DRINK – SAFE FOR HANDWASHING ONLY". We are working with our facilities department and NJ DOE to determine our course of action for these outlets.

Brigantine North Middle School

Twenty samples were taken at ten locations – the first was non-flushed and the second was flushed. All Brigantine North Middle School (10 locations) outlets tested below the 15ppb benchmark when flushed. This indicates that the elevated reading is coming from the immediate area of the faucet/outlet – lead was often used in plumbing materials until it was banned in 1986. Since the initial results were elevated, those outlets can and will be replaced. The water will remain shut off to these locations until the faucets are replaced and testing is completed to confirm the correction of the issue.

Our school system is committed to protecting student, teacher, and staff health. We will continue our efforts to protect our community and remain in compliance with the Department of Education.
