- Ms. Shelly Eager reported that the district Early Childhood Program has earned a designation of Gold Circle of Quality from ExceleRate Illinois which is our state's quality rating and improvement system for early learning and development programs.
- Mrs. Pollee Craven reported that the high school has been celebrating Homecoming week this week, starting with the crowning of the royalty on Monday morning. The Homecoming queen is Kenzie Blentlinger and king is Jacob Flynn. A huge thank you goes out to the Student Council and sponsors for their preparation and planning for the week and to the cheerleaders and Mrs. Hohenbery for the awesome hall decorations.

Mrs. Craven also recognized Coach Tom Little on his 100th career win. And she reported that beginning in the spring of 2017, all students in the state of Illinois will be taking the SAT instead of the ACT. Across the state, the ACT has been the traditional college entrance exam; however, we will now begin preparing students to take the SAT.

Ms. Karen Jirjis reported that the science club is up and running. Fifty students have signed up to participate. The sponsor will be holding separate meetings for 7th grade and 8th grade since the numbers are large. Plans are being made to take the 7th and 8th grade students to Springfield in March to attend Doktor Kaboom. This is a high energy science show covering various rocket science topics. Ms. Jirjis reported that the Literacy group is participating for their contest which will be held November 5th in Carthage.

The middle school will be hosting a book fair during parent teacher conferences. Profits will go to help classroom teachers purchase materials for their classrooms and to purchase books for the library.
