CASWELL COUNTY BOARD OF EDUCATION MINUTES Special Called Meeting May 9, 2018

The Caswell County Board of Education met in a special called meeting on Wednesday, May 9, 2018, at 4:00 p.m. in the Board Room located at the Administrative Offices of Caswell County Schools. I. CALL TO ORDER
