- Let bids on boiler replacement will move forward. Did receive \$50, 000 School Maintenance Grant to aid in expense. Will involve removal of old boiler and smoke stack. Smoke stack could be left in place but poses hazard due to lose bricks at top.

Discussion on updating student handbooks: Updating of handbooks necessary to make everything uniform from elementary through high school in regards to attendance and discipline issues. New item in handbook is a consent form for parents to sign to allow pictures of their student on the school website.
